Dear Mr. Hale:

As the lawsuit filed by Alameda County and nine other jurisdictions draws to an end, these public agencies will soon receive significant funding to conduct lead hazard abatement work. To successfully complete the work within the four year window created by the court order will be a significant challenge. If the funds are not expended within the court-ordered window for abatement activities, unexpended funds must be returned to the defendants, reducing the amount of lead remediation that will be completed. Consequently, we need to increase the number of certified individuals capable of performing testing, risk assessment, supervision, and completion of lead hazard reduction work by shortening the period of timelines for training and examination.

To prevent the potential loss of funds, the Board of Directors at the Alameda County Lead Poisoning Prevention Program urges the California Department of Public Health to do the following:

- Increase the number of lead hazard-related construction certification exam opportunities
- Arrange to offer certification exams in additional locations so as to increase the number of examinees
- Provide expeditious review and approval of applications for certification

We understand the Department may face barriers or other challenges to expanding testing opportunities and accelerating the application review process. Our Board of Directors and legislative supporters are eager to be of assistance wherever possible. We hope to discuss the above-listed items with you in the near future.

Mr. Hagen informed Directors that the Department of Toxic Substances Control is hosting a regional update meeting at Elihu Harris State Building in Oakland on Tuesday, Jan. 29, 2019 from 6:00-8:00PM. Topics to be presented include Lead Acid Battery Recycling, Investigation and Clean up. The announcement was distributed at the meeting.

Mr. Hagen referenced an article, "Oakland's Lead Paint Problem Persists", by Oakland Magazine which both Mr. Brooks and Director Gwen Hardy were interviewed. The article informs of a lead poisoned child with high blood lead levels in North Oakland and the city's response in addressing lead hazards.

Furthermore, an article by Discover Magazine June 2018 edition informs of dental evidence of environmental exposures. The article indicates that teeth and bones can reveal past exposure of lead and other elements/chemicals before birth noting that African American children are more exposed.

Assistant Secretary of the Board, Lidice De La Fuente, stated that in December 208 the Department conducted a healthy homes and lead poisoning prevention training for the Berkeley's Tobacco Program and staffed the Emeryville Holiday Tree Lighting.

Dale Hagen stated the Department hosted a paint litigation planning meeting on January 23, 2019. During the open forum of the meeting, Association of Northern California Environmental Consultants (ANCEC) informed that training resources for qualified workforce is a challenge to carry out lead remediation work and implementing the lead litigation funds. Directors expressed their concern about the training challenges noting the need for expediting training process and certifications, regional and State coordination and spending the funds. Directors asked staff to draft a letter to the State of California Childhood Lead Poisoning Prevention Branch and other officials requesting to increase the number of certification exams and to diversify the locations where the certifications are held to make them more accessible to people. Lastly, the Department continues discussions about the lead paint litigation with City of Oakland. Directors asked for clarification on the timeline for implementation.

Mr. Hagen informed that Mr. Brooks appeared before the Grand Jury Subcommittee for independent living homes along with other key stakeholders on January 10th, 2019. The purpose is to gather more information and for the Grand Jury to provide for recommendations. A report on the findings is expected June 2019.
