The meeting was called to order at 9:46 A.M.

#### 1) Open Forum

No public comment.

#### 2) Goals and Objective for Fiscal Year 2016-2017

Maricela Foster introduced the Department's Goals and Objectives for Fiscal Year 2016-2017, noting that this year's document is reformatted and goals have been consolidated into three overarching goals; **Public Outreach**, **Healthy Housing Assessments and Interventions** and **Cooperative Compliance**. Ms. Foster and Mr. Brooks reviewed the goals and objectives for the year providing a summary of changes that include the incorporation of lead assessments into all home site visits regardless of port of entry as a primary prevention strategy and staff will continue to conduct traditional outreach strategies.

**Action:** The Board approved the Goals and Objectives for Fiscal Year 206-2017.

#### 3) Budget for Fiscal Year 2016-2017

April Williamson, Finance Manager, presented the Department's Budget for Fiscal Year 2016-2017 focusing on the budget for CSA and noting that total revenue is stable representing a small decrease from the prior fiscal year. Ms. Williamson stated that discretionary items included funding for a fund development consultant to assist with researching grant opportunities; a training consultant to assist with the Department's trainings; and, temporary staffing. Ms. Williamson stated that outreach and education is seen in the staffing and that fifty percent of staff is field staff. Ms. Williamson also reminded the Board of the renewed building lease, which the Department staff presented to the Board in May 2016. Lastly, Ms. Williamson stated that the salaries and benefits of staff have increased four percent from last year, due to a new contract with SEIU. Director Atkin asked whether the Department has a long range plan for diversify its portfolio. Ms. Foster informed the Board that portfolio diversification is one the top priorities for the Department's sustainability plan.

Ms. Williamson provided information on the budget process stating that the budget is reviewed and approved at many levels within the County including at the Alameda County Board of Supervisors. Ms. Williamson noted that the County's final budget deliberations will be conducted on June 24, 2016 with final adoption by June 30, 2016.

#### 1) Open Forum

No public comment.

# 2) Director's Report

Larry Brooks, introduced the Community Development Agency's Web Access Report for the month of May 2016, highlighting the number of times that Department websites are visited. Mr. Brooks stated that according to the report the Department's What's New Page was visited a total of 984 times and viewed 1,133 in May 2016. The Department's page was ranked number two on the list for the entire Agency for pages with the most hits.

Mr. Brooks also informed the Board that the Department participates on the Byrne Grant Engine Team, a grant initiative led by the Alameda County Sheriff's Office with support from the Alameda County Board of Supervisor Nate Miley's Office. Mr. Brooks stated that beginning July 1, 2016, a community event series, Eden Night Live, will be taking place each Friday and Saturday evening at the intersection of Hampton Road and Mission Blvd., in the Cherryland Area of Hayward. These series will showcase local entrepreneurs, artisans, performers, and community-based organizations. Mr. Brooks stated this is one of the ways in which the Department is partnering to increase economic development, social cohesion, and public safety in the Unincorporated Area.

Maricela Foster stated that with the assistance of Alameda County Board Supervisor Wilma Chan's Office the Alameda County Board of Supervisors will proclaim National Healthy Homes Month on their June 28<sup>th</sup>, 2016 Board meeting. Ms. Foster stated that this is the first ever month-long celebration offering an opportunity to learn more about housing and its impact on health. A video was played, developed by the U.S. Department of Housing and Urban Development highlighting Secretary, Julian Castro proclaiming June as National Healthy Homes Month.

#### 3) Third Quarterly Report FY 15/16

Mr. Brooks highlighted two Oakland events; Safe Kids Day 2016 where over 1,500 people learned about Department services and the School's Out Resource Fair at Arroyo Viejo Park where approximately 600 children were served. Other highlights mentioned were the Department providing 193 children with one of two types of promotion services, case management or lead poisoning consultations. Mr. Brooks informed the Board of the Department challenges for the quarter, which included a decrease in Lead cases occurring both at the local and national level. Due to the decrease in lead cases the Department is in the

process of reevaluating intervention and outreach strategies by creating a proactive housing assessments for the identification of lead poisoned and lead exposed children. Additionally, challenges identified in the third quarter were the inability to schedule workforce trainings with key partners such as Laney College. Mr. Brooks stated that the Board will see an increase in trainings in the fourth quarter report due to the Mold Workshop held in April and the U. S. Environmental Protection Agency's Renovate, Repair and Paint Rule initial training held in May 2016.

# 4) Public Awareness and Education Report

Lidice De La Fuente reported on the outreach activities conducted in the month of April 2016 stating that staff conducted presentations at two Neighborhood Crime Prevention Council meetings in the San Antonio and Eastmont Districts in Oakland and at Eastmont WIC, where WIC staff will distribute the California State Department of Public Health's materials to encourage blood lead testing and HUD Lead Hazard Control materials to their clients who met the criteria.

Ms. De La Fuente also highlighted an increase in the number of In-Home Consultations conducted in the cities of Oakland and Berkeley adding that staff anticipates meeting the goal for the fiscal year. Ms. De La Fuente stated that the reason for this increase in In-Home Consultations is due to the warm weather and property owners gearing up for conducting home repair and gardening projects. Director Marilyn Ezzy Ashcraft asked about the Department's outreach strategies in the City of Alameda. Mr. Brooks stated that the Department partners with multiple agencies in the City of Alameda including the Alameda Housing Authority for outreach to property owners.

#### 2) Director's Report

Ms. Foster reminded Directors that on May 23, 2016, the Healthy Homes Department presented two projects to the Alameda County Health Committee for Measure A funding for the Fixing to Stay and Group Living Facilities projects scheduled for the July 12, 2016. Ms. Foster stated that the Fixing to Stay Project will partner with Alameda County's Public Health Department to address housing conditions of older adults. The Group Living Facilities Project will partner with the "Strike Team" to improve housing conditions in partnership with Health Care Services Agency. The Department anticipates starting the projects in mid-July 2016.

Ms. Foster announced the Department has a clerical non-benefited employment opportunity, in partnership with the hiring contractor, Prescott Joseph Center for Community Enhancement, Inc., for a Healthy Homes Administrative Support position for a 12 month assignment. Hard copies of the job announcements were made available at the meeting.

Ms. Foster indicated that Larry Brooks and Dale Hagen attended the National Center for Healthy Housing Conference in San Antonio, Texas from June 13 through June 16, 2016. Mr. Brooks stated that at the Conference, the California Healthy Housing Coalition, which the Department is an active participant were awarded with the HUD's Secretary's Award. Directors Marilyn Ezzy Ashcraft and Ruth Atkin praised the Department for the award.
