Director John J. Bauters opened the Program Operations Committee meeting at 9:15 A.M.

#### 1) Open Forum

### 2) Director's Report

Secretary to the Board, Larry Brooks, alerted Directors that the Department was asked by the U.S. Department of Housing and Urban Development (HUD) and U.S. Environmental Protection Agency (EPA) to attend a press release announcing new rules regarding lead dust sampling as part of the President's Taskforce Federal Action Plan to reduce childhood lead exposure. Mr. Brooks stated that JPA Directors John J. Bauters and Gwen Hardy are attending the press release event in West Oakland after the JPA Board meetings. Directors were invited to the event.

Mr. Brooks announced that the Department is the co-recipient of the National Association of Counties Achievement Awards for asthma intervention work. The award is the result of the Pay for Success Initiative / Coordinated Health and Housing Asthma Management Program (CHHAMP), a joint project with Alameda County Health Care Services Agency Asthma Start Program.

Moreover, on June 14, 2019 the Alameda County Board of Supervisors issued a proclamation for Healthy Homes Month 2019 noting Healthy Homes Department and Healthy Havenscourt Collaborative, a placed-based collaborative comprised of residents, community-based organizations, and public agency partners are working together to strengthen long-term health outcomes for residents and create a healthier neighborhood.

Mr. Brooks stated that a Reuters reporter is interviewing Department staff and families affected by lead poisoning for an upcoming article on the lead paint judgment. Mr. Brooks noted that the City and County of San Francisco could not provide a family affected by high lead levels of lead poisoning for the interview because the County does not see those type of cases. According to City and County of San Francisco officials they are proactive, and they intervene at lower blood lead levels, therefore, preventing high levels. Mr. Brooks reminded Directors that it is the goal of the Department to intervene at lower levels similar to the City and County of San Francisco.

# 3) Outreach and Education Monthly Report

Assistant Secretary of the Board, Lidice De La Fuente informed Directors that as of May 2019 the Department surpassed its objectives for the fiscal year for Direct Public Outreach, which is 151 percent and 101 percent for Indirect Public Outreach. The Department is optimistic that it will achieve the objective for Healthy Housing Interventions.

#### 2) Director's Report

Larry Brooks stated that the Department will begin discussions with Alameda County's Health Officer and Alameda County Public Health Department Director to strategize on how to respond to mold complaints. The discussions were prompted by the California State Department of Public Health which highlighted concerns that neither the County or City of Oakland are responding to mold complaints.

Mr. Brooks informed that recently the U.S. Supreme Court ruled that it will allow Flint, Michigan residents affected by lead in water crisis to sue officials that were involved.

#### 3) Lead Paint Litigation

### A) County Update/timeline

Mr. Brooks stated that jurisdictions in the lead paint litigation met on June 19, 2019 and they expect a final judgment on June 24, 2019. Mr. Brooks noted that once final judgement is made the paint companies will have 60 days to provide funds to receiver and jurisdictions anticipate receiving the funds in September 2019. Jurisdictions are scheduled to meet on July 17, 2019.

Directors discussed the draft advisory letter that would inform public agencies of the lead paint companies' intentions to sue property owners who seek lead paint litigation funds to remediate home lead hazards. Directors discussed the list of recipients to include tenant, legal groups and local government jurisdictions. Recipients considered are: Causa Justa/Just Cause; Bay Area Legal Aid, East Bay Community Law Center; Centro Legal de la Raza; California Apartment Owner's Association; Berkeley Rent Board; realtor associations; local housing authorities, local public health departments, grassroot organizations; city administrators, city managers and city attorneys.

Director Lynnette Gibson McElhaney recommended citing the name of the court case in the introductory section of the letter; a public service announcement to go along with the letter and having talking points, comments, and or written statements ready. Mr. Brooks recommended adding the link to Assembly Bill 206, (Chu), Public Nuisance: Abatement: Lead-based Paint, which would nullify property owners from any fault caused by lead based paint in their properties. Director Gwen Hardy recommended adding Lead Poisoning Prevention Program to

the letter.
