4) Director's Report

Secretary April Williamson welcomed new Directors to the JPA Lead Board.

Ms. Williamson reported that between 800 to 1,000 children with elevated blood levels are referred to the Healthy Homes Department for support and intervention through comprehensive case management services. In the past four months the Department has assessed 89 homes to identify and eliminate safety hazards and beyond home assessments the Department has empowered over 3,000 Alameda County residents with education and resources equipping them with knowledge to create and maintain healthy homes for their families.

6) Meeting Location

Alternate Valerie Arkin introduced the agenda item noting that the proposed change to the meeting location is being made on behalf of JPA Director and Alameda County Board of Supervisor Nate Miley.

7) Goals and Objectives FY 25/26

Secretary Williamson stated the Goals and Objectives document includes all Department programs and services which are funded by multiple sources.

In response to Alternate Valerie Arkin regarding outreach to schools, Secretary Williamson stated the Department provides ongoing technical assistance and education to all schools including the Oakland Unified School District. Additionally, Ms. Williamson clarified that the previous JPA Lead Board of Directors recommended that City of Oakland allocate lead settlement funds to fund repairs at Oakland Unified School District sites with lead fixtures and emphasized that the Lead Settlement funds already allocated to Oakland are under their discretion and not Alameda County.

In response to Director Igor Tregub's questions regarding concerns with federal funding, Ms. Williamson indicated that the Department has two main sources of federal funding including grants by the U.S. Department of Urban Development that are already in contract and committed and Community Development Block Grant funding, which is at risk for reduction in funding.

Furthermore, Ms. Williamson stated that the reorganization efforts reflected in the document are in alignment with the proposed goals. The Department has experienced many shifts with staffing and is training staff and preparing for succession planning and considering different sources of funding for its long-term mission and goals.

Secretary Williamson stated the Department will implement the technical advisement committee, which is a formed by interdisciplinary health, housing, environmental and outreach professionals to discuss unsafe conditions and develop a best approach. Ms. Williamson offered to provide additional information on the committee at a future meeting.

Ms. Williamson emphasized that while the Department does not have enforcement capabilities for addressing unsafe conditions, it works collaboratively with code enforcement officers and building officials by providing training and technical assistance to assist in the enforcement.

In response to Director Noel Gallo's question regarding identification of lead poisoned children, the Secretary to the Board stated that if a child has been identified with an elevated blood lead level, the California Department of Public Health has a monitoring system tied to every jurisdiction in which the Department and the medical provider are notified simultaneously at which time the Department staff begins coordination of care. The City of Berkeley has its own surveillance system due to having its own public health department.

Lastly, the Department has five new project-based positions funded by HUD Healthy Homes Production Grant and Older Adults Modification Grant.





Report for May 2025 Public Outreach


By June 30, 2025, Alameda County residents will be reached and informed of CSA property owner services, lead safety, childhood lead poisoning prevention, training, maintaining a lead-safe property, minor home repair and the impact of housing on health. Direct outreach to an estimated 5,000 residents will be done through community events such as presentations, information booths, training, and lead consultations, etc. An estimated 1 million individuals will be reached through multi-media campaigns (radio, T.V., social and print), collaboration meetings, mailings, webpage, etc.





Healthy Housing Assessments/Interventions

By June 30, 2025, a total of 425 healthy housing assessments / interventions will be conducted in the homes of Alameda County residents participating in the Lead Hazard Control Program, Lead Poisoning Prevention Program, Minor Home Repair programs, Fixing to Stay and Independent Living Homes Project or when responding to unsafe renovation condition complaints.
