February 23, 2023

Director John J. Bauters called into order the teleconference for the Meeting of the Board of Directors at 9:00 A.M.

3) Consent Items

3.1 Resolution AB 361: Open Meetings State & Local Agencies 3.2 Meeting Minutes for February 23, 2023

Meeting minutes were not noticed properly. No action taken. JPA Board asked to agendize the January 26, 2023, and February 23, 2023, meeting minutes for the next JPA meeting.

4) **Director's Report**

Director Gwen Hardy arrived at item #4.

Secretary to the Board, Larry Brooks, informed Directors that Alameda County Board of Supervisor, Nate Miley, was appointed to serve on the JPA Board of Directors representing the County of Alameda.

Mr. Brooks stated that Senator, Bob Archuleta has introduced Senate Bill 356, Housing: Code Enforcement Incentive Program: Community Code Enforcement Pilot Program. SB 356 would increase the maximum grant from \$450,000 to \$2,000,0000 under the Community Code Enforcement Pilot Program and would require certified code enforcement officers. Grant funds would provide for many jurisdictions to come into compliance with AB838. In response to Director Noel Gallo, with experience with City of Oakland, Mr. Brooks stated that funds might be used to advance Oakland's Proactive Inspection Program and increase RRP training. Additionally, Mr. Brooks stated that letters of support in support of legislation would be helpful.

Mr. Brooks announced that the Department will assist the U.S. Environmental Protection Agency, EPA, in administering their new grant program for teaching communities about lead poisoning prevention. EPA is offering two in-person and virtual Lead Awareness Curriculum sessions for community leaders and the general public. EPA Region 9 is seeking advise from the Department on how to disburse the funds in different communities throughout the State and consult with the Hawaiian Code Enforcement Officers Association.

Additionally, the Department asked the Alameda County Board of Supervisors for authorization to submit a grant application to the U.S. Department of Housing and Urban Development for up to \$5.7 million for the development of a Lead Hazard Control Program to address residential lead hazard and healthy housing issues.

Mr. Brooks alerted Directors that the Department partnered with ChangeLab Solutions to put on a national webinar attended live by 498 people. Mr. Brooks served on a panel discussing Policy Making for Housing Justice Unpacking the Equity of Challenge of Housing Code Enforcement.

5) Mid-Year Outreach Activities Report

Lidice De La Fuente provided highlights for the Department's outreach and education activities for period July-December 2022. Ms. De La Fuente reminded Directors that in the Summer of 2022, the Department hosted a series of focus groups with CSA property owners to get owner feedback on the type of services and information that would be helpful to them. In response, the Department has been building our capabilities in the use of online and social media to get the information out to property owners, is re-establishing the in-home lead safety consultation program among our service offerings. Last quarter, the Department partnered with Oakland Housing Authority to develop the "Roadmap to a Healthy Home" educational tool. A community engagement tool (flyer) to provide residents with information and resources to keep themselves and their family healthy in their home. Also, three trainings were held in October in partnership with Cypress Mandela in Oakland and 27 trainees became certified renovators. The Department also hosted a series of workshops about Lead in Soil, Ask Healthy Homes, and mold.

Moreover, recruiting units for the Lead Hazard Control and Minor Home Repair programs has been a challenge due to impacts of the COVID pandemic, challenging relationships between owners and tenants, economic uncertainty for property owners and changing demographics. In an effort to increase referrals, the Department has increased both traditional and social media and will be training code enforcement officers on lead hazards.

6) Monthly Report

Ms. De La Fuente stated that the Department has worked with translators to add fully translated FAQ pages in nine languages. Additionally, the Department has created a YouTube playlist for people to learn about lead poisoning prevention and healthy homes principles in shorter, easy to follow videos.

7) Future Agenda Items

Director Wengraf will not be available to attend the March 23, 2023, meeting. Director John J. Bauters asked to inform Department staff of any conflict with meeting in person next month.

8) Announcements by Board Directors

Director Bauters recognize Black History Month stating lead poisoning disproportionally affects people of color in Alameda County.

4) Brown Act Compliance: Limited Options for Remote Meetings

County Counsel Andrew J. Massey informed the JPA Board of limited options for remote meetings and Brown Act compliance after February 28, 2023.

Mr. Massey reminded staff that AB 361 enabled the JPA Board to meet remotely and excluding the public from attending the meetings in person. That ability will go away when the emergency declaration will be rescinded at the end of February 2023.

The new law, AB 2449, has limited impact and is intended to be used for emergency purposes allowing a member of the legislative body who intends to attend an in person meeting to appear remotely due to unforeseen circumstances that prevents them from attending in person. AB 2449 is limited to two times in a 12-month period and disclosure for not attending the in-person meeting is required.

A quorum of the legislative body must be present within the JPA's jurisdiction if each JPA Director prefers to use their own location for the meeting. Additionally, all locations need to be noticed, agenda must be posted at each of the locations, each location must be publicly accessible, ADA compliant and within the boundaries of the JPA. Mr. Massey noted administrative requirements for tracking the number of times the authority has used AB 2449 and having sufficient administrative staff facilitating the meetings at each of the locations. Director John J. Bauters asked Directors to contact Ms. Lidice De La Fuente for the Just Cause exemption and to provide advance notification to accommodate for any consolidation or rescheduling of meetings. He reminded Directors that starting in March 2023, the JPA Board will reconvene in-person meetings at Emeryville City Hall at 9:30 a.m.

Board continued onto item #6.

5) **Director's Report**

Secretary to the Board, Larry Brooks, announced that Lisa Plourde, Senior Registered Environmental Health Specialist is retiring after 29 years of service with Alameda County. Directors and staff thanked Ms. Plourde for her service.

Mr. Brooks announced that Alameda County Board of Supervisor Nate Miley plans on joining the JPA Board to represent Alameda County.

The Department invited Emery High and United for Success Academy/Frontline Catalyst students to apply for the U.S. Environmental Protection Agency Region 9 Environmental Youth and Teachers Award. Applications were due January 11, 2023.

California Association of Code Enforcement Officers (CACEO) and Regional Asthma Management & Prevention (RAMP) are promoting the restoration of code enforcement incentive grants to assist local code enforcement agencies achieve their goals and are looking for a legislative champion to lead it. Grant funds will assist code enforcement agencies with purchasing much needed supplies and equipment to further their goal.

Lastly, Mr. Brooks announced he will serve as speaker at the Equity Challenges of Housing Code Enforcement webinar on January 31, 2023, at 11AM hosted by ChangeLab Solutions.


Lidice De La Fuente highlighted that the Department is now on Tik Tok and had 840 profile visits on Twitter which is more than 344 from the previous month.



Report for February 2023 Public Outreach


By June 30, 2023, Alameda County residents will be reached and informed of CSA property owner services, lead safety, childhood lead poisoning prevention, training, maintaining a lead-safe property, minor home repair and the impact of housing on health. Direct outreach to an estimated 5,000 residents will be done through community events such as presentations, information booths, trainings, and lead consultations, etc. An estimated 1 million individuals will be reached through multi-media campaigns (radio, T.V., social and print), collaboration meetings, mailings, webpage, etc.





Healthy Housing Assessments/Interventions

By June 30, 2023, a total of 514 healthy housing assessments / interventions will be conducted in the homes of Alameda County residents participating in the Lead Hazard Control Program, Lead Poisoning Prevention Program, Minor Home Repair programs, Fixing to Stay and Independent Living Homes Project or when responding to unsafe renovation condition complaints.
