MISSION STATEMENT

Our mission is to advance an integrated approach for safe and healthy housing, through collaborative community initiatives, applied research and policy development to improve the lives of vulnerable populations.

We do this by:

- Promoting comprehensive lead safety.
- Providing case management to lead poisoned children.
- Providing technical consultations, training and education to the public, property owners and renovators.
- Researching and demonstrating effective programs to address the environmental determinants of health.
- Working in community and stakeholders' collaborations to leverage existing resources.
- Developing infrastructures and promoting system change to provide coordinated, cost-effective support for healthy housing.

ABOUT THE DEPARTMENT

The Alameda County Healthy Homes Department's (ACHHD) primary goal is to create safe and healthy housing by promoting an integration and nexus between housing and public health policy. The Department also works to shape an environment that sustains long-term healthy housing conditions to improve health outcomes in Alameda County; it does this by providing case management, public education, outreach, training, housing assessments and interventions, influencing relevant housing policies and regulations, applied research, building cross-sector alliances and workforce development.

The Department's proactive healthy homes strategy is the incorporation of a lead visual assessment on all homes where staff is conducting a site visit (in person), regardless of reason for the initial port of entry. This strategy is a proactive primary prevention approach that increases the number of homes where a lead assessment is done.

The Department provides the services above through funding by the local County Service Area (CSA) service charge for owners of pre-1978 properties in Alameda, Berkeley, Emeryville and Oakland, the California Department of Public Health (DPH), the U.S. Department of Housing and Urban Development (HUD) Office of Lead Hazard Control and Healthy Homes.

In addition, the Department contracts with the City of Oakland and City of Union receiving a Community Development Block Grant (CDBG) and County Measure A funding to provide minor home repair services to low-income homeowners including the elderly and disabled. The Department also contracts with the Oakland Housing Authority to provide healthy housing assessments and resident education.

SUMMARY OF MAJOR CHANGES

The proposed goals and objectives for Fiscal Year 2025/2026 include activities such as outreach events, home visits and increase in social media presence. For this fiscal year, activities will be developed, implemented, and continually assessed.

The Healthy Homes Department will educate and engage the public on lead poisoning prevention measures and services supporting the nexus between health and housing. In Fiscal Year 2024/2025, the Healthy Homes Department will partner with community allies, industry organizations and leverage collaborations with local small business partners to encourage public engagement in the Healthy Homes community.

The Alameda County Healthy Homes Department will continue activities under the Lead Safe Alameda County Program benefiting those areas of Alameda County outside of Oakland, including other cities and the unincorporated area of the County. The Department will remain available to discuss the use of lead settlement funds targeted for Oakland whenever the city staff receives a final report from their consultant estimated to be in the summer of 2025.

The California Department of Public Health agreement for countywide child lead poisoning prevention services increased by 75 percent in Fiscal Year 2023-2024, but newly added objectives and deliverables still pose challenges for providing adequate funding to support Fiscal Year 2023-2026 contract requirements (including staff needed to fulfill those objectives).

The Department will implement the Lead Hazard Control Grant in the amount of \$5.7 million with end term of 2027. This round of funding allows the Department to continue to provide safe remediation of low-income residential units where lead hazards in older housing that pose a threat to young children in Alameda County.

The Department is the recipient of two new HUD grants to fund expansion of lead poisoning prevention services to vulnerable communities under the Healthy Homes Production Grant and expansion of minor home repair with the Older Adults Home Modification Grant Program. The Older Adults Home Modification Grant Program aims to solve accessibility issues, minimize health risk and improve the living standards of enable low-income seniors (age 62+) to safely age in place and avoid institutional care.

Furthermore, the Department will continue the Fixing to Stay Project, this is a partnership with health and social services partner agencies to improve the lives of older adults living in-homes in need of minor repairs and/or accessibility modifications, by applying multi-strategy home interventions that include home hazard reduction so older adults can live securely and remain independent.

The Department will negotiate new contract agreements with the City of Union City and City of Oakland to administer their minor home repair programs. Contract agreements are expected to be finalized in the first quarter of the new fiscal year.

Reorganization Efforts. ACHHD launched organizational development activities which began in 2023 and included a thorough inventory and review of all contractual and legal obligations for the administration and delivery of department services. ACHHD leaders conducted a SWOT analysis and interviewed team leads to understand the organizational strengths and challenges with program implementation and expansion.

Moving forward, the Fund Development team will work in collaboration with department sections to identify and apply for fundraising opportunities that align with our system's values and strategic plan. Fund development activities will prioritize donor expansion, program expansion, and promote community engagement.

- Develop and implement multi-media (radio, tv, social media and print media) campaigns educating the public and encouraging engagement in lead prevention measures.
- Distribute and maintain program services brochures in at least 3 key community locations that are visited by property owners in each CSA city Participate in regional Head Start Health Advisory Board meetings (live and/or virtual) to promote lead screening.
- Participate in collaboration meetings (live and/or virtual) with key community groups and organizations.
- Maintain partnerships with rental industry organizations such as East Bay Rental Housing Association, Berkeley Property Owners Association, Property Managers Associations and establish new contacts with homeowner associations in the CSA cities to increase their knowledge of the impact substandard housing has on health.

- 4) CLPPP will continue to conduct the targeted provider outreach campaign by completing 6 comprehensive provider presentations by December 31st, 2025. The outreach campaign will include at least 2 offices that serve primarily low-income, high-risk children such as Federally Qualified Health Centers (FQHCs). The outreach campaign will aim to improve blood lead screening rates (especially among populations will below the national benchmark) by provision of information, education, and literature that focuses on state mandates for BLL screening requirements for both publicly and privately insured children in the state.
- ACHHD will work with provider offices to collaboratively develop internal clinical screening tools to better identify children at higher risk for lead poisoning that may not fall into mandated screening categories set by the state.
- Collaborate with identified providers to complete training sessions and workshops to improve screenings rates (education provided will also include state mandates for BLL screening for both publicly and privately insured children). Additionally, lead education and outreach efforts will also focus on different types of sources of lead exposure identified in Alameda County, especially focusing on non-housing sources and identifying families at elevated risk due to possible cultural sources in the homes (e.g. Ayurvedics or medicinal remedies).
- The provider outreach campaign will also be modified to include aggregate data demonstrating lower screening rates in certain demographic populations based on the annual DHCS Preventative Services Report to improve provider awareness and address related knowledge gaps.
- **5)** By June 30th, 2026, CLPPP will identify a new case management software platform to improve client tracking and documentation, and to streamline data analysis for creating equity driven program interventions and outcomes.
- Key ACHHD staff will provide data requirements and specifications to prospective vendors (vendor selection will go through standard county procurement procedures as indicated when applicable).
- Once vendor is identified, key staff will be formally trained on program workflow in the new system following the purchase process of needed licenses.
- Vendor selection criteria will include the ability to run comprehensive data analysis reports to identify health equity gaps in populations served.

- 9) By June 30th, 2026, 30 Healthy Housing assessments will be conducted under the HUD production grant to identify (and provide) needed low-cost housing interventions to promote health outcomes of lead-poisoned children and families.
- CLPPP staff will identify eligible children and families impacted by lead-poisoning for receiving health-related, low-cost housing interventions and healthy homes assessments.
- The Housing Rehabilitation Specialist will conduct Healthy Homes Assessments to identify low-cost housing interventions specifically connected to poor health outcomes.
- The Housing Rehabilitation Specialist will complete scopes of work to coordinate with contractors from the approved contractor pool to complete low-cost home interventions and/or modifications as indicated.
- The Community Development Technician will complete income verification during the intake process to ensure the family meets eligibility criteria.
- The program manager will conduct environmental reviews for all active projects as indicated and required by the grant and Office of Lead Hazard Control and Healthy Homes.






By June 30, 2025, Alameda County residents will be reached and informed of CSA property owner services, lead safety, childhood lead poisoning prevention, training, maintaining a lead-safe property, minor home repair and the impact of housing on health. Direct outreach to an estimated 5,000 residents will be done through community events such as presentations, information booths, trainings, and lead consultations, etc. An estimated 1 million individuals will be reached through multi-media campaigns (radio, T.V., social and print), collaboration meetings, mailings, webpage, etc.





Healthy Housing Assessments/Interventions

By June 30, 2025, a total of 425 healthy housing assessments / interventions will be conducted in the homes of Alameda County residents participating in the Lead Hazard Control Program, Lead Poisoning Prevention Program, Minor Home Repair programs, Fixing to Stay and Independent Living Homes Project or when responding to unsafe renovation condition complaints.
