Director John J. Bauters opened the Program Operations Committee meeting at 9:15 A.M.

1) Open Forum

2) Director's Report

Secretary to the Board, Larry Brooks, informed the Board that the California Department of Public Health (CA DPH) addressed the JPA Boards concerns related to the California lead-related construction certification and exams. CA DPH responded that they will provide four additional exams; work with counties to determine locations for the FY 2019/2020 exams and provide expeditious review and approval of applications for certification. Director John J. Bauters offered to host a training if need to. Mr. Brooks announced that CA DPH Childhood Lead Poisoning Prevention Branch has a new director and expects the official announcement to be made at the April 26, 2019 Bay Area Lead Poisoning Prevention meeting. Copies of the letter from the State was circulated at the meeting.

Mr. Brooks thanked Director Susan Wengraf for alerting him of the article "I Found Lead in my Historic House", by Alissa Walker. He also thanked the city for passing policy directing ordinances related to lead safe practices and reimbursement costs. The Department expects to continue to coordinate enforcement efforts with the city.

Mr. Brooks stated that the Department continues to do public awareness and outreach on social media including posting lead related videos and articles. Recently, the Department posted an article on lead in candies and purses highlighting that enforcement of the California Proposition 65 toxic chemical labeling law has resulted in significant decrease in amount of lead found in certain candies and colorful purses. The Department will soon begin to promote lead poisoning prevention on Twitter and Instagram.

Mr. Brooks thanked City of Alameda Code Enforcement agency staff for collaborating on an unsafe renovation complaint involving lead and asbestos on Lincoln Avenue in Alameda.

3) Outreach and Education Monthly Report

Assistant Secretary of the Board, Lidice De La Fuente stated that as of March 2019 the Department is at 70% of its goal for housing assessments and interventions. Directors asked staff to identify lead related housing assessments and interventions.

Larry Brooks thanked Directors for their leadership and support in requesting positions from the Alameda County Board of Supervisors. At the April 8th, 2019 Budget Hearing the County approved four positions to increase service levels. Four additional positions will be requested once the lead paint judgment funds are received.

3) Audit Report for Fiscal Year Ended June 30, 2018

Larry Brooks informed Directors of the Department's yearly audit noting there were no findings. Mr. Brooks referred to page 7, Economic Factors and page 18, Organization and Significant Accounting Policies stating the economic factors impacting the Department and need to increase the County Service Area service charge through a ballot measure.

Furthermore, he referred to page 24, Contingent Liabilities, Litigation indicating the paint company's intentions to sue property owners and making public records act requests to obtain property owner information. Directors asked for documentation of the public records act requests, KALW report and recommended an advisory letter to landlords, public jurisdictions, local legal providers and members of the California Apartments Association (CAA). Mr. Brooks stated he would follow up with Assembly member Chu's office who were introducing legislation to try to protect property owners from the paint companies obtaining information.

Secretary to the Board, Larry Brooks announced that on April 30, 2019, Oakland Unified School District (OUSD) will hold a press conference on Tap Water/Soda Tax/Lead Abatement. He thanked Directors for their effective communication with OUSD acknowledging Director Wengraf who attended a previous OUSD board meeting to address lead concerns at OUSD schools.

Moreover, Mr. Brooks stated he is the chair of the Healthy Housing Coalition's new Lead Poisoning Prevention Workgroup.

Recently, the Department received a letter from a city of Fremont high school student concerned about lead poisoning. The student recommended that all jurisdictions adopt more laws such as the 2006 Lead Based Paint Poisoning Prevention Law in Rochester, NY requiring inspections for lead paint hazards as part of the City's existing housing inspection process. City of Oakland Alternate William Gilchrist expressed interest in learning more about Rochester's lessons learned around tenant displacement.
