#### **MEETING MINUTES**

April 26, 2018

1) Open Forum

#### 2) Director's Report

Secretary to the Board, Larry Brooks, announced that the Oakland Unified School District Board of Education adopted lowering the standard for lead in water to 1 parts per billion by 2019. The current level is 15 parts per billion.

Mr. Brook introduced Sharon Murray, U.S. Environmental Protection Agency (EPA) Superfund Program Site Manager who discussed the upcoming West Oakland Lead Cleanup and Soil Study taking place April 2018 to June 2018. The study will include the excavation and cleanup of 11 yards located close to a former smelter and analyzing for 16 different metals and manganese. Ms. Murray stated that EPA is also conducting the soil study to better understand the presence of lead, and other heavy metals, in the soil in West Oakland. As a result of meeting with the West Oakland Indicator's project, EPA staff will produce a fact sheet geared towards the community explaining the study. A fact sheet announcing the study geared towards agencies was distributed at the meeting. Directors invited Ms. Murray to the September 2018 JPA Board meeting to discuss the results of the study.

Department staff wrote an article appearing on the March 2018 California Health Department Program (DPH) Newsletter discussing lead screening challenges. Mr. Brooks noted the resistance from the medical community and the perception that higher income households are not affected by lead poisoning. Director Susan Wengraf stated that regulations are limiting the testing to those in lower economic groups with assumptions that they're more at risk for lead poisoning. Director John J. Bauters noted that physicians and pediatricians opposed Assembly Bill 1316 Universal Testing. Director Desley Brooks indicated changing legislation requiring blood lead testing to be included with immunizations could serve as early intervention. Director Gwen Hardy noted that People United for a Better Life in Oakland (PUEBLO) also received push back from the medical community. Mr. Brooks added that the Department staff follows the State DPH criteria for conducting environmental investigations at 15 micrograms per deciliter.

Larry Brooks alerted Directors of the KALW public radio series, "Persistent Poison: Lead and the Bay Area Housing Crisis", an in-depth look at childhood lead poisoning in the Bay Area, which has been well-received and has gotten national attention. Mr. Brooks stated he would share the series at the next meeting.

### 3) Outreach and Education Monthly Report

Lidice De La Fuente stated that the Department staff conducted two mass mailings to promote lead hazard control program reaching out to Oakland Housing Authority participants and lead poisoning prevention to WIC participants. Ms. De La Fuente noted that the delay in healthy housing interventions is due to the delay in the implementation of the Fixing to Stay Program and the shortage of contractors able to conduct work under the Lead Hazard Control and Minor Home Repair Programs. The Department staff has conducted contractor outreach at local businesses frequented by contractors including Home Depot.

Mr. Brooks stated that the shortage of contractors is due to contractors focus on new construction; construction in other areas such as Santa Rosa, CA and the shortage of EPA Renovate Repair Paint (RRP) certified contractors. The Department continues to promote the EPA RRP trainings to contractors.

Director Bauters thanked staff for staffing Emeryville's Spring Community Expo.

Larry Brooks alerted Directors that the Department's Audit report was completed and no findings were reported. He noted that the audit is conducted every year and is a part of U.S. Department of Housing and Urban Development requirement. Bound copies were made available to Directors at the meeting.
