Director John J. Bauters opened the Program Operations Committee meeting at 9:27 A.M.

1) Open Forum

2) **Director's Report**

Secretary to the Board, Larry Brooks, informed that during National Lead Poisoning Prevention Week he and Healthy Housing Rehabilitation Specialist, Rosa Hernandez appeared on the Public Broadcasting Service Retro Report which featured a segment on the Legacy of Lead.

Mr. Brooks alerted Directors of an unsafe lead renovation complaint going on for three weeks at a rental property on Athol Avenue in the City of Oakland involving a four-year-old child. Mr. Brooks stated that the Department responded to the complaint and asked the landlord and contractor to stop the unsafe work practices, which they did. The landlord also agreed to take the Environmental Protection Agency's (EPA) Renovate, Repair, Paint Rule (RRP) class, however, was unable to train the contractor due to language barriers. Mr. Brooks stated that he informed Councilmember Bass and City of Oakland Building and Planning Department who wrote a notice of violation that included a 35-day response period. Director Lynette Gibson McElhaney asked Department staff to inform her of unsafe renovation / condition complaints directly and sooner and that she would investigate the 35-day response period legislatively. Director Gwen Hardy expressed the need for protocol on Department staff relaying information to Directors regarding unsafe renovation/condition complaints. Director Bauters asked that Department staff inform the relevant jurisdiction on the Lead Board in advance and have an offline conversation as well as to return with a proposal on steps identifying how the Department staff will engage the JPA Board including community advocates on addressing the matter. Director Bauters also informed staff of the Alameda County Mayor's monthly meetings, which the Department could present on the subject.

Mr. Brooks informed the JPA of the CNN report indicating that 95% of tested baby foods in the U.S. contain toxic metals and The Washington Post report on EPA's overhauling how communities must test for lead in water. Director Hardy expressed concern that so many products come to the U.S. from other counties and are often unregulated.

Mr. Brooks informed Directors that the California Department of Public Health Childhood Lead Poisoning Prevention Branch released their funding allocation application. The Department will apply for a three-year contract in the maximum amount of \$2,593,338 to fund countywide case management of lead poisoned children, education and outreach to medical providers and families to increase blood lead screening. Mr. Brooks noted the amount of funding has not increased and will lobby the State for additional funding.

Recently, the Department was awarded a \$3.6 million grant from the U.S. Department of Housing and Urban Development for a three- and half-year Lead Hazard Control program in Alameda County. As part of the celebration the Department issued a press conference and a check handout ceremony on October 15, 2019. Mr. Brooks thanked Directors Bauters and Supervisor Wilma Chan for participating in the event, which was captured by KQED, East Bay Times and the Berkeley Patch.

Mr. Brooks had no update on the lead paint settlement negotiations with city of Oakland.

Larry Brooks stated that in a joint presentation with City of San Diego, CA he presented on Mold and Lead Regulations and Laws at the California Association of Code Enforcement Officers (CACEO) Annual Seminar in early October 2019 in San Diego, CA. Mr. Brooks stated that he was appointed to the CACEO Board of Directors where he will attempt to advance legislation to empower Code Enforcement Officers to respond to mold and lead complaints. Additionally, the EPA was impressed with the Department's trainings results in training 150 Code Enforcement Officers on RRP and is looking at additional funding for the Department to continue training individuals. Director McElhaney stated that video training for a fee such as program income would amplify the training curriculum.

6) Announcements by Board Directors

Director Hardy alerted Directors that she had been under the weather recently, but that she celebrated her 77th birthday on October 17, 2019. Mr. Brooks mentioned that Director Hardy and PUEBLO were featured along with the Black Panther Party and Supervisor Chan on advancing lead poisoning prevention during National Lead Poisoning Prevention Week.

Director Vella stated a referral had been made to the Alameda City Council for its November 2019 meeting to create a separate division for code enforcement to focus on the health and safety aspects of code enforcement and to create a code enforcement officer position and additional code enforcement position to work on alternate weeks to cover weekend and evening hours.

Director Bauters stated that on Tuesday, October 29, 2019, the City of Emeryville will vote on a ballot measure proposing for a code enforcement position reportable to the Emeryville City Manager.

Director Susan Wengraf informed of a proposal to have the Rental Safe Housing Division implement a program that addresses undocumented and unpermitted units in the City of Berkeley. She also noted that the City is also updating their zoning regulations.
