4) Director's Report

Director Welch arrived [teleconference] at agenda item #4.

Secretary April Williamson provided an update on the potential ballot measure for increasing the County Service Area fee adding that the survey results and recommendations by the consultants will be shared with the Directors at a future meeting. Director Igor Tregub asked for a report on the services residents that are impacted would be getting under this proposed ballot measure.

Ms. Williamson stated the Department is ramping up activities under two new grant programs, Healthy Homes Production Program and Older Adults Home Modification Program but is experiencing a minor slowdown due to the Federal shutdown. Ms. Williamson indicated she does not anticipate the short-term delays will majorly affect the two new grants.

Ms. Williamson announced that Katie Gulyas was promoted to Assistant Director of Operations and will be attending the next JPA meeting to present on the referral process for lead poisoned children and medical provider outreach strategies.

Considering recent U.S. Immigration and Customs Enforcement activity in the area, Ms. Williamson reassured Directors that the Department does not disclose any client information to immigration authorities.

In response to Director Noel Gallo's request for an update on the lead settlement negotiations with the City of Oakland, Ms. Williamson stated the next step is for Oakland staff to present to the County their program design which is anticipated in the fall of 2025. Director Gallo asked Department staff to assist with coordinating with Oakland a report back to the JPA on their program design.



Report for October 2025 Public Outreach


By June 30, 2026, Alameda County residents will be reached and informed of CSA property owner services, lead safety, childhood lead poisoning prevention, training, maintaining a lead-safe property, minor home repair and the impact of housing on health. Direct outreach to an estimated 5,000 residents will be done through community events such as presentations, information booths, training, and lead consultations, etc. An estimated 500 thousand individuals will be reached through multimedia campaigns (radio, T.V., social and print), collaboration meetings, mailings, webpage, etc.





Healthy Housing Assessments/Interventions

By June 30, 2026, a total of 425 healthy housing assessments / interventions will be conducted in the homes of Alameda County residents participating in the Lead Hazard Control Program, Lead Poisoning Prevention Program, Minor Home Repair programs, Fixing to Stay and Independent Living Homes Project or when responding to unsafe renovation condition complaints.
