Director Noel Gallo called into order the Meeting of the Board of Directors at 9:30 A.M.

1) Roll Call

3) Consent Items

3.1 Meeting Minutes for June 26, 2025

Action: The Board approved the meeting minutes for June 26, 2025.

4) Director's Report

Director Tregub arrived at agenda item #4.

Secretary April Williamson provided an update on the lead settlement funding indicating that through June 2024 the Department has spent \$3.7 million of the allocated \$9.5 million to enhance existing services in Alameda County outside of the City of Oakland. Services include community outreach, training on Environmental Protection Agency (EPA) Renovate, Repair, and Painting and staff to provide services to lead poisoning children.

Ms. Williamson reminded Directors that in 2021 the County of Alameda and Oakland signed an Interim Memorandum of Understanding for the disbursements of appropriately \$23.9 million awarded to both the County and City of Oakland. Twenty percent went to City of Oakland, 40% went to the Department and 20% is to be negotiated. There is no timeline for spending the funds.

Moreover, at the end of June Department staff met with city of Oakland staff on a preliminary overview on the City's program design for an equitable lead hazard control program in the City of Oakland.

Additionally, City of Oakland applied for a U.S. Department of Housing and Urban Development (HUD) Lead Hazard Control grant in the amount of \$4 million to complete remediation in 51 housing units. The Department staff and Oakland staff will hold preliminary discussions on how to collaborate to avoid overlapping of services in Oakland.

Ms. Williamson informed Directors that the County Service Area fee has been set at \$10 per pre-1978 dwelling unit since 1991, therefore, the Department has hired consultants to do polling for the feasibility of increasing the fee. Ms. Williamson stated she expects poll results in the next two weeks.

Director Noel Gallo asked which other cities have significant lead-based paint issues at which time Lead Hazard Control Program Manager, Rosa Hernandez, indicated the concentration has been in West Oakland, Fruitvale district and Berkeley due to oldest density in housing stocking in Alameda County.

Director Gallo inquired about reporting lead poisoned children from Children's Hospital Oakland and asked how many Oakland children have been impacted by lead poisoning. Ms. Williamson stated the number of lead poisoned children has stayed at a steady pace and the Department will hold presentations on the Department's in-depth work for better understand the matter.

Also, in response to Director Gallo's question on lead concerns by Oakland Unified School District, Ms. Williamson stated the Department is in communication with the Oakland Unified School District and one of key messages is to get children lead tested.

Director Igor Tregub inquired about upcoming workshops and community events to include in their newsletters. Ms. Williamson stated staff would follow up with the community outreach manager.

5) Selection of Community Representative

Lidice De La Fuente provided an update on the selection of the At-Large Community Representative, requesting that Directors assist in the recruitment of qualified members from the community to serve this role. Ms. De La Fuente asked JPA Directors to forward their nominees' cover letter, resume or curriculum vitae to <u>Lidice.delafuente@acgov.org</u> by Monday, December 1, 2025.

Nominees will be invited to the January 2026 JPA Lead Board Meeting for introductions and answer any questions from the JPA Board members. It is the intention that the JPA Board members will elect the non-voting At Large Community Representative at that same meeting.

Director Courtney Welch asked for a blurb for advertising the vacant seat on multiple media outlets.

6) JPA Meeting Frequency for Year 2026

Due to multiple meeting cancellations in year 2025 and for accommodating Director's schedule, Ms. Williamson inquired about the feasibility of meeting quarterly in lieu of monthly. Directors were receptive to the idea of meeting quarterly in year 2026. Ms. De La Fuente stated the meeting calendar for 2026 will be an action item in October.

7) **Monthly Report**

Ms. De La Fuente stated the Department continues to develop new leaders, informing the community and helping people make their homes healthier by connecting key partners with other community organizations, therefore, advancing awareness for lead poisoning

prevention and healthy housing. Most recently the Department connected the East Bay Academy of Young Scientists (EBAYS) with the unincorporated area via the Eden Area Community Coalition. In October they are doing a four-week pilot program, with 20 young adults from the neighborhood. They will be studying lead in the community, its origin, the environmental justice implications and developing a call to action. This first session will be held at the Eden United Church of Christ (EACC), but other organizations such as Reach, San Lorenzo School District and others have expressed an interest in hosting other sessions. In addition, the EACC has been asked to apply for a foundation grant to help support the program.

8) Lead Hazard Control Presentation

Rosa Hernandez, Lead Hazard Control Program Manager, presented on the lead-based paint hazards showcasing participating lead hazard control housing units.





Alameda County Healthy Homes Department Outreach and Education Report Objectives FY 25-26

Report for September 2025 Public Outreach

By June 30, 2026, Alameda County residents will be reached and informed of CSA property owner services, lead safety, childhood lead poisoning prevention, training, maintaining a lead-safe property, minor home repair and the impact of housing on health. Direct outreach to an estimated 5,000 residents will be done through community events such as presentations, information booths, training, and lead consultations, etc. An estimated 500 thousand individuals will be reached through multimedia campaigns (radio, T.V., social and print), collaboration meetings, mailings, webpage, etc.





Healthy Housing Assessments/Interventions

By June 30, 2026, a total of 425 healthy housing assessments / interventions will be conducted in the homes of Alameda County residents participating in the Lead Hazard Control Program, Lead Poisoning Prevention Program, Minor Home Repair programs, Fixing to Stay and Independent Living Homes Project or when responding to unsafe renovation condition complaints.
