#### MEETING OF THE BOARD OF DIRECTORS MEETING MINUTES

September 28, 2023

Director John J. Bauters called into order the teleconference for the Meeting of the Board of Directors at 9:32 A.M.

#### 3) Consent Items

#### 4) **Director's Report**

Director Gwen Hardy arrived at item #4.

Secretary to the Board, Larry Brooks, informed Board members that Alameda County Community Development Agency is putting together a new website that will inform tenants of their eviction protection strategies.

Mr. Brooks indicated that members of the statewide lead paint settlement workgroup met in August at the Lead and Healthy Housing Conference. Each of the participating jurisdictions presented on how their plans for spending the lead settlement funds. He noted that Oakland/Alameda County are the most progressive in expanding lead poisoning prevention services and seeking corporate and private partnerships. City and County of San Francisco plan on doing window replacements while other jurisdictions will do lead paint remediation on interior and exterior of homes similarly to the U.S. Department of Housing and Urban Development (HUD) Lead Hazard Control Grant Programs. Monterey, San Mateo and Solano Counties have no experience in the field of lead. Ventura County plan on expanding their work after receiving a HUD Lead Hazard Control Grant. Mr. Brooks stated he encourages jurisdictions to expand on their lead poisoning prevention services. He noted that some jurisdictions are contracting out with companies that do not have the expertise.

Mr. Brooks gave examples of other cities with proactive rental inspection programs and their successes after implementing their programs. Mr. Brooks referenced and offered to share with

Directors, "A Guide to Proactive Rental Inspections" by ChangeLab Solutions and "An Analysis of Proactive Rental Inspection Policies in California".

Mr. Brooks informed the Board of the West Oakland Lead Sampling Report by the Environmental Protection Agency (EPA). Mr. Brooks stated he advocated for advance notification to elected officials representing West Oakland and Oakland City Council prior to report being released to the public. Mr. Brooks stated that EPA is recommending doing testing of soil in the backyards of residential properties in West Oakland, however, not declaring the area a Superfund Site nor providing any funding for cleanup. Director Susan Wengraf expressed concern for lead contamination in Berkeley. Director Malia Vella asked for clarification on criteria for declaring Superfund Sites and advocated for Department to add to their recommendation strategies informing school district officials of the matter.

Additionally, Mr. Brooks stated that the Department is working with the California Healthy Housing Coalition on resurrecting the universal blood lead testing bill.

Director Wengraf thanked Director Gwen Hardy for her activism, leadership in the community.

Directors asked staff to provide printed copies of future presentations.

#### 5) Monthly Report

Soni Johnson, Department's Outreach Coordinator, indicated that in response to EPA's West Oakland Lead Sampling report the Department has developed strategies to alert the community in West Oakland on how to continue to remain lead safe by distributing safety sheets and promoting the Department's In-Home Consultation services to residents and local communitybased organizations.

Ms. Johnson informed Directors of the Department strategies associated with tenant rights organizations including a train the trainer with my Eden Voice, participating in the Owner Appreciation event with Oakland Housing Authority Section 8 voucher program. Ms. Johnson stated the Department is seeking stronger relationships with Alameda and Berkeley Housing Authorities. Landlord outreach including collaborating with several local rental housing associations and participating on a symposium for rental property owners to specifically to provide clarity and inform services available.

Future events in the County Service Area include a tabling event at the Pride Festival, and presentations to Kindercare and PTA's in the city of Alameda. In Berkeley participating in Dia de los Muertos at Berkeley High School on October 31, 2023, and working with Berkeley's Heart 2 Heart program on training and incorporating lead poisoning prevention messages. In Emeryville, the Department has planned presentations to their city council, and promoting Department services and key messages on Emeryville newsletters. In Oakland, the staff will participate in the Town Hall at DeFermery Park on November 5<sup>th</sup> hosted by the West Oakland Indicators Project.

In preparation for National Lead Poisoning Prevention month in October the Department's theme is "There's More to Know About Lead" while the California's Childhood Lead Poisoning Prevention Program is "Lead in Aviation Fuel". Ms. Johnson stated that staff is conducting a proactive outreach campaign within the areas that are one mile within Oakland Airport to dispel any myths about lead poisoning and inform about potential sources and how to be lead safe. Director Vella offered to connect staff with contacts at Bay Farm Island to relay this information.

Ms. Johnson indicated that calls regarding unsafe renovation concerns in Alameda and Oakland have increased and recommended proactive strategies by the responding agencies to alleviate the problem.

The Department has also increased their foreign language capacity to Cantonese, Mandarin and Spanish and staff is conducting outreach at local food banks and food distribution sites.

Additionally, the Department is implementing a Countywide outreach program for home-based childcare and center-based childcare by end of the year. Outreach program will focus on ensuring there are no lead hazards in the facilities, informing of proper nutrition to combat lead hazards and providing funding availability to remediate lead hazards in home-based childcares.

Lastly, Alameda County is launching a Housing Quality Services Survey specifically to tenants in the Unincorporated area to learn about deficiencies in their homes.






### Alameda County Healthy Homes Department Outreach and Education Report Objectives FY 23-24

#### **Report for September 2023 Public Outreach**


By June 30, 2024, Alameda County residents will be reached and informed of CSA property owner services, lead safety, childhood lead poisoning prevention, training, maintaining a lead-safe property, minor home repair and the impact of housing on health. Direct outreach to an estimated 5,000 residents will be done through community events such as presentations, information booths, trainings, and lead consultations, etc. An estimated 1 million individuals will be reached through multi-media campaigns (radio, T.V., social and print), collaboration meetings, mailings, webpage, etc.







By June 30, 2024, a total of 455 healthy housing assessments / interventions will be conducted in the homes of Alameda County residents participating in the Lead Hazard Control Program, Lead Poisoning Prevention Program, Minor Home Repair programs, Fixing to Stay and Independent Living Homes Project or when responding to unsafe renovation condition complaints.
