Director John J. Bauters chaired the meeting at 12:01 P.M.

1) Open Forum

2) Director's Report

Secretary to the Board, Larry Brooks, informed JPA Directors of a letter from the Alameda County Board of Supervisors to the California State Legislature delegation regarding lead paint litigation negotiations. Mr. Brooks stated that the Board of Supervisors requested that the litigation decision remain intact and for Alameda County to receive unrestricted funding for case management of lead poisoned children, outreach and education to promote blood lead screening and lead safety training. Mr. Brooks added that the paint companies made an offer of \$745 million in exchange for legislators to introduce a bill that would provide immunity to the paint companies for lead related liabilities. County Counsel rejected the offer, but are willing to continue the negotiations. Director Desley Brooks requested a Microsoft Word version of the letter; a matrix that outlines the Court's decision, settlement offer, compromise with legislators; and, the Department's perspective on how it's prepared to move forward should a resolution be reached in the case. Director Brooks questioned how the Legislature could make a decision on Court cases where a decision has been rendered noting the ex post facto law and how legislators can negotiate on behalf of the jurisdictions involved in the litigation. Hard copies of the letter sent to the California Legislature was distributed at the meeting.

Mr. Brooks alerted Directors that the Reuters series, *Exposing the Hidden Hazards of Lead Poisoning Across America*, *Lead's Hidden Toll*, won the 2018 National Press Club Award for investigation into lead poisoning in the U.S. Mr. Brooks noted the series includes a report on California and a visit with Emeryville JPA Director Bauters.

Moreover, Mr. Brooks provided Directors with an update on the U.S. Department of Housing and Urban Development (HUD) requirement for environmental investigations at all Section 8 properties involving lead poisoned children. Mr. Brooks stated that the California Department of Public Health who owns the data will not release it due to confidentiality concerns. Director Brooks asked for a panel presentation in September or October 2018 by the directors of local housing authorities to provide clarification on HUD's requirement for environmental investigations in the homes of lead poisoned children.

3) Outreach and Education Monthly Report

Lidice De La Fuente noted formatting changes for the monthly report highlighting charts and a new category, *Other Alameda County Cities not in the CSA*.

4) End of Year Report FY 17/18

Ms. De La Fuente reported on the End of Year Report for Fiscal Year 2017-2018, noting that the Department met their goals and objectives with the exception of the housing interventions. Ms. De La Fuente stated that staff reviewed the housing interventions which were reported at 215 at the last JPA meeting, however, the final count is 324 for the fiscal year. The increase of housing interventions was attributed to the project completions under the housing rehabilitation and minor home repair programs that had not been tallied in the monthly reports.

2) Director's Report

Larry Brooks introduced Brandon Kitagawa from the Regional Asthma Management Prevention who serves on the steering committee of the California Healthy Housing Coalition. Mr. Kitagawa provided an update on the 2016 bill authored by California Senator Bill Monning and reintroduced last year recommending that the California Department of Public Health (CA DPH) administer regulations of the U.S. EPA Renovation, Repair, and Paint Rule (RRP) program. Mr. Kitagawa indicated that the bill fell through due to lack of interest by CA DPH in taking on the responsibility. Mr. Kitagawa recommended jurisdictions look at local solutions similar to the model in the City of San Diego, which has the highest compliance rate than anywhere else in the State. Mr. Brooks noted that the lack of RRP certified contractors is a challenge and will present a bigger problem for ramp up when the lead paint litigation funds come through.

Director Mary Hatsume Vella recommend reaching out to other organizations including the California Building Trades and legislators such as California Senator Nancy Skinner who chairs multiple committees and has relationships with departments that may be involved in the matter.

Furthermore, Mr. Brooks stated that Department staff and Oakland's Mayor, Libby Schaaf, were interviewed by Univision Television Network for a segment on lead poisoning prevention efforts. Department staff will alert JPA Directors when the segment is broadcasted.

Mr. Brooks announced that Kansas City residents passed the "Healthy Homes" initiative, a rental inspection program. The program will be funded by a \$20 per unit annual fee from landlords, due when they register their properties with the city. If problems go uncorrected after an initial inspection, landlords must pay a \$150 re-inspection fee. Subsequent inspections will cost \$100.
