In the next few months, County staff and consultants will produce a Community Climate Action Plan (CAP) for the Unincorporated Areas of Alameda County. We are seeking input from residents, organizations, and businesses in this process. The CAP will contain objectives, measures, and actions to reduce greenhouse gas emissions from activities within the community such as:

- Transportation choices (e.g. improving bicycle infrastructure and bus links)
- Water conservation (e.g. efficient appliances and use of rainwater)
- Waste diversion (e.g. improving recycling and composting services)
- Building and public realm energy use (e.g. energy efficiency retrofits)
- Green infrastructure (e.g. expanding the urban forest)

County resolution R-2006-204 mandates that the Unincorporated Areas establish greenhouse gas reduction targets and develop an implementation and monitoring plan to achieve those targets. Many CAP measures may also benefit the local community with improved air quality, lower energy bills, and reduced traffic congestion.
