The Alameda County Child Care Planning Council convened on May 17, 2013 to identify the key priorities and create action plans for 2013 - 2014. The goals included:

- Foster a sense of community that supports aligning personal, interpersonal and collective forward movement.
- Review the accomplishments of 2012 -2013 within the current context.
- 3. Create action plans for 2013 2014 that support the achievement of the three-year goals.
- 4. Create council recruitment plans for specific constituencies.

RETREAT SUMMARY

Creating Community and Team Development

Significant time was allotted for the Council to develop relationships, as well as explore the diversity that exists within the group. Activities began with diversity rounds that grouped council members according to different categories to understand similarities and differences. This continued with a

conversation on community. As a result, it seemed that individuals gained a greater appreciation of each other and their resonance to the purpose of the Planning Council. The activities allowed for small group interactions as well as an in-depth one-on-one opportunity.

To incorporate new members into the council, committees created journey maps to tell the story of their work. This activity introduced by staff sharing the historical timeline of the planning council.



To set the journeys within current context, staff shared some "current realities" with the council. In particular, the following bullet-points were shared:

Twenty-one of the participants wrote reflections at the end of the day. In terms of the first goal of fostering community, comments included:

I believe we were pretty successful in forging a community of people invested in a common goal: making sure our kids all get quality care.

I think we accomplished a sense of community in an excellent way. I had the time to talk with people I never really talked to during the initial activities and during the committee activities.

I think the day was a nice blending of new comers and old timers. I was able to speak and learn about other council members who I may not perhaps have opportunities with.

The council and committee journeys provided insight. I can tell from comments throughout the day that the community building activities were greatly appreciated.

Providing the history of the CCPC and committees helped to ground the conversation and give a platform to use as we move forward. I think it focused the group work in a way that would be helpful to do in the larger CCPC meetings.

Reviewing Accomplishments and Action Planning



In support of the second and third goal of the convening, the council members (in mixed small groups) began the afternoon capturing achievements and raising questions regarding the five greater goals of the council. Many participants commented that the time for this activity was too short to really understand the deeper implications of the accomplishments. However, this data provided some guidance for the committees to begin action planning for 2013. In addition to identifying a 2014 goal and listing the activities and resources needed, the committees also indicated benchmarks to help monitor their progress at three months, six months and nine months.

The three committees' action plans were summarized for the entire group.

Early Childhood Committee

- Offer a platform for QRIS participants to process and provide feedback of their experience.
- Reach out to 22 sites
- Develop communication strategies to increase participation and maximize input
- Develop benchmarks.

State contractors

- Design two events for all publicly funded programs and consumers to foster shared knowledge and build community.
- Collect/ analyze date by city, district, need for care.
- All 7 Headstart grantees meet, build community and appeal.

Public Policy

- Deal with realign, gather parent feedback
- By Nov, draft advisory
- Link with Parents
- Healthcare: health exchange impact on CC providers

Some of the reflections from these activities included:

Recording accomplishment reflected overlap and also provided detail on major accomplishments that could be forgotten (i.e., remembering defeat, forgetting to celebrate success – this gave us a chance to celebrate success).

I learned that I really want to start going to the public policy committee meetings.

We were able to review what the ECE committee has achieved and the group was able to create a good action plan.

Creating the action plan was very hard, but I felt we had a very productive conversation and we had enough time.

I appreciated braking up into groups of interested areas. It allowed me to ask questions to gather information in the near future so I am better prepared to address public policy issues at hand.

Recruitment and Zip Codes Action

The council met into constituent groups to develop recruitment plans – parent, providers, public agency and community. Reflections from the participants indicated that this allowed members to have "illuminating" conversations. In particular participants discussed "where to look and what to look for" while considering who could benefit from and contribute to the council.

Finally, the council took action on zip code priorities. This was a formal council matter that included a motion and vote.

Conclusion

In the closing the council acknowledged that the day was a good start, but many of the plans do need some refinement. There was much appreciation for the opportunity to get to know others "on a deeper level" and set the knowledge of each other within the context of the council's work. A number of participants reflected that they "got a better sense of what the planning council does!"
