#### **CAO's Corner**

We were relieved that Congress reached an eleventh-hour agreement to avoid the "fiscal cliff" that many said would send the country spinning back into recession.

But with the short-term relief comes long-term concern, as many experts indicate the deal didn't solve underlying problems the "fiscal cliff" was set up to address. And it seems likely that the agreement has only kicked the issue a few months forward, as Congress and the White House prepare for what could be an even bigger fight over the debt ceiling in February.

There also are significant concerns with the "fiscal cliff" deal itself. Some people are upset because President Obama and the Democrats agreed to reduce the amount of new revenue by raising the earnings-threshold for higher taxes to \$400,000 for individuals and \$450,000 for couples. Others dislike the deal because it in effect raises taxes imposed on upper-income Americans but deferred decisions on possible spending cuts for two months. And that's the focus of our concern, because we won't know what the impact on Alameda County will be until Congress decides on those spending cuts. Our objective now will be to remind the decisions makers in Washington that any spending cuts they enact will impact important programs helping people in our community.

# **Alameda County Names New Fire Chief**



Demetrious N. Shaffer has been appointed Alameda County Fire Chief. Chief Shaffer's appointment was made official by the Board of Supervisors in late December. He served as Interim Fire Chief since June 2012, following former Fire Chief Sheldon Gilbert's resignation. "We are thrilled to announce the appointment of Demetrious Shaffer, who we believe will be an outstanding Fire Chief for Alameda County," said Nate Miley, President of the Board of Supervisors. "I also want to extend my sincere thanks to Chief Shaffer, who served with great distinction over the past six months as our Interim Fire Chief." Shaffer began his career as a firefighter in Mountain View and steadily moved up the ranks before being appointed as the Newark Fire Chief in 2005, and is the current president of the California Fire Chiefs

Association. He has successfully demonstrated his leadership during challenging financial times, and has been integral in consolidation efforts geared at achieving regional efficiencies in the delivery of fire services. Susan S. Muranishi, County Administrator, said, "We look forward to working with Chief Shaffer and know that the department and the County will benefit from his past experience as a chief and his statewide leadership role."

The Registrar of Voters Office is conducting a special election on March 5 in the City of Piedmont, where voters will be asked whether to approve a parcel tax to raise funds for city schools. Poll workers hired by Alameda County will operate six polling places in Piedmont on Election Day. The deadline for voters to register for this election in February 18. Voters will also be allowed to request Vote-By-Mail ballots between February 26 and March 5. These ballots must be received by the Registrar by 8 p.m. on Election Day.

## Alameda County Employees Walk the Extra Mile for Heart Association

# **Project Search Graduates Stand Tall**

Mine adults with developmental disabilities were honored on January 31 for completing year-long internships with Alameda County as part of a special collaboration that provides onthe-job experience for in-dividuals with special needs. These nine special individuals made up the third graduating class of the County's Project SEARCH Program. Project SEARCH allows interns to develop their job skills by becoming fully immersed in



a large workplace and opens the door to possibilities for gainful employment. The program is a partnership between Alameda County, East Bay Innovations and the Oakland Unified School District. Twelve members of the first and second graduating classes were placed in permanent employment following their Project SEARCH internships, while two members of the latest graduating class have already secured permanent jobs. Overall, five interns from the first three graduating classes have secured permanent jobs with Alameda County, including one of this year's graduates who has begun working for the Auditor-Controller's Office. County Administrator Susan S. Muranishi, one of the driving forces behind Project SEARCH, continues to urge County department heads to consider Project SEARCH graduates when looking to fill administrative support positions. To provide the interns with a range of experience, the program called for each of the interns to complete assignments with three different County departments during their year-long stints.
