Responses to Written Questions

- Q1) Is there a ballpark figure for the contract
- A1) No funding amount has been disclosed for this RFQ.
- Q2) Is Rapid Rehousing type included in this RFQ
- A2) No. Rapid Rehousing is not included in this RFQ.
- Q3) Will this be an ongoing RFQ
- A3) Yes, this will be an ongoing RFQ that will be released quarterly unless ACPD feels service needs are met.
- Q4) Under the vendor pre-qualifications on page 8: "Bidder must be regularly and continuously engaged in the business of providing housing services to the adult realigned population or Juvenile population for the past 24 months utilizing evidence-based correctional practice(s) that are widely accepted as strategies to reduce future criminal behavior." Does this include only providing housing services to the target population under contracts specific to re-entry clients, or can we demonstrate qualification by describing services to people who are in the realigned target population, but whom we served under a non-re-entry-specific contract?
 - A4) Yes, you can demonstrate qualifications by describing housing services to the realigned target population that were served under a non-re-entry specific contract.
 - Q5) Is there a minimum number of beds per vendor that you plan to fund?
 - A5) No minimum is specified in this RFQ.
 - Q6) Are the beds required to be held solely for Probation? E.g., if a vendor proposes 10 beds within a shelter that has overlapping programs, would those 10 beds be 100% obligated to Probation, or could a vendor fill the beds from other programs if there were not enough eligible Probation referrals?
 - A6) No, beds are not required to be held for Probation referrals only.
 - Q7) On page 10, the RFQ states that "5.If possible, Bidder will have the ability to implement and monitor a rental subsidy component." Should we incorporate rental subsidy costs into our budget and proposed per diem rate?
 - **A7)** Yes.
