- Q1) Can funds be used to purchase a rental house?
- A1) No, funds may only be used to support the operations of licensed Adult Residential Facilities or Residential Care Facilities for the Elderly.
- Q2) Can the funds be utilized for Reasonable Accommodation Modification? Shower grab bars, wheelchair ramp, etc.
- A2) Please see response to Q1 above.
- Q3) What are the key points funders are looking for, from a startup organization?
- A3) To be eligible to participate in this RFPQ process, Bidders must have a current Community Care License at the time bids are due, along with additional minimum qualifications. Please see Section D., Bidder Minimum Qualifications on page 7 of the RFPQ.
- Q4) Where does the opportunity lie for non-traditional housing? I.E. mobile homes etc.?
