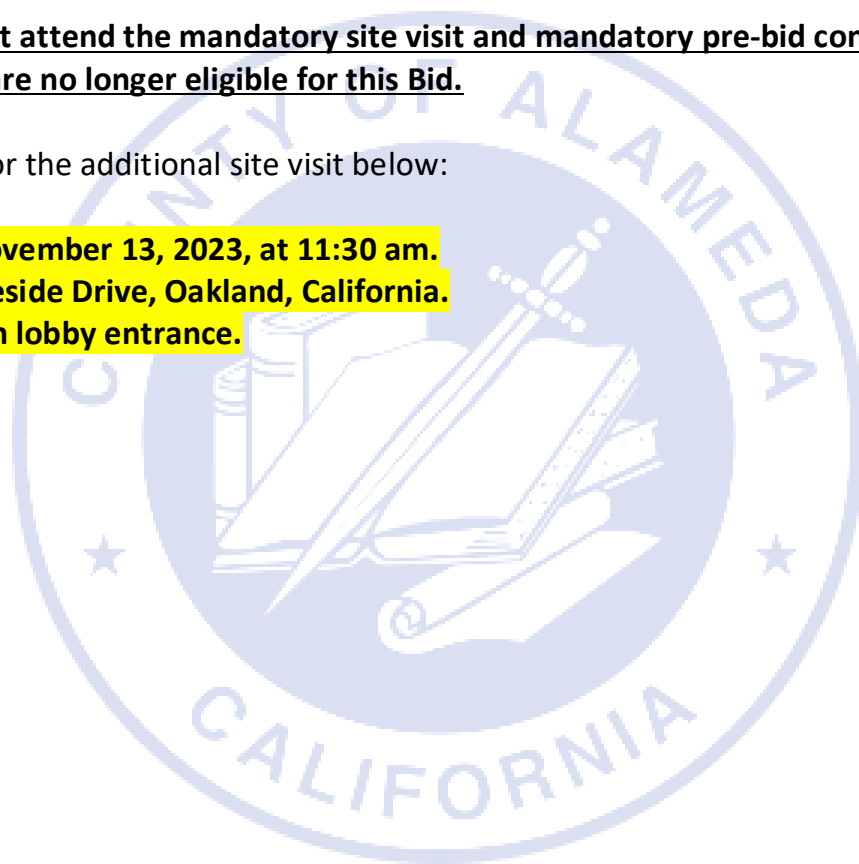
**Bidders who did not attend the mandatory site visit and mandatory pre-bid conference held on October 19, 2023, are no longer eligible for this Bid.**

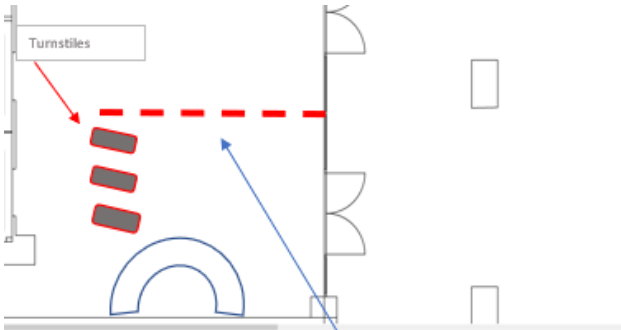
