## **RECOMMENDATION:**

Award and execute a contract (Master Contract No. 902377, Procurement No. 26408) with Saitech, Inc. (Principal: Sam Sharma; Location: Fremont) to provide rugged patrol vehicle laptops to the General Services Agency – Motor Vehicle Department, for the term of 5/1/24 – 4/30/27, in the amount of \$1,682,898 (\$1,516,123.75 + 11% estimated sales tax).

# **DISCUSSION/SUMMARY:**

General Services Agency—Motor Vehicles Department (GSA-MVD) is responsible for the administration of the County's fleet of light and heavy automotive equipment owned and operated by GSA. MVD's responsibility is to ensure that the County's fleet is safe to operate, properly maintained and economically feasible. MVD also provides services to other agencies and departments to ensure their equipment is safe and maintained.

The MVD intends to purchase rugged laptop computers with all necessary peripherals to replace or supplement existing laptop computers in patrol vehicles. These laptops will be used daily by Alameda County Sheriff's Office employees and deputies to conduct business throughout the County.

### **SELECTION CRITERIA/PROCESS:**

The GSA-MVD has determined that Alameda County does not currently have the resources to provide rugged patrol vehicle laptops.

The GSA-MVD worked with GSA—Procurement to develop a Request for Quotation (RFQ), which was posted on the County and GSA LinkedIn websites on October 20, 2023, posted on the website for 27 days, emailed to the Chambers of Commerce e-mail group, and sent to the E-Gov Goods and Services — Current Contract Opportunities mailing service. The RFQ was also advertised in The Inter-City Express on October 24, 2023, and the San Francisco Daily Journal on October 24, 2023. A vendor outreach was conducted on October 25, 2023, followed by one networking/bidders conference on October 26, 2023, which was attended by one vendor.

On November 16, 2023, one bidder submitted a response to the RFQ. The response was evaluated by GSA-Procurement, GSA-MVD, and the Sheriff's Office based on the lowest pricing and meeting the County's requirements of the required Rugged Patrol Vehicle Laptops.

Saitech, Inc. was the sole qualified bidder who submitted the response, met all requirements, received favorable references, and is being recommended for an award.

Saitech, Inc. is a certified Small Local Emerging Business (Certified Small: 15-00086; Expiration: 09/30/2024).
