








 - Step 2: Request for Proposal (Bids) issued only to pre-qualified

- Contract award will be on the "Lowest Responsive Lump Sum Bid" basis

Selection Process – Step 2

Project Bidding Process

- Notification of qualification issued to all firms
- Submit a signed Non-Disclosure Agreement (NDA) form to receive a link to the RFP Bid Documents (drawings and technical specifications)
- Submit Site Clearance forms for all staff intended to visit the job site
- Issue Requests for Proposals (RFP/Bids) to pre-qualified contractors only
- Conduct a formal RFP meeting / site walk
- Receive signed and sealed bids from pre-qualified Contractors
