Brief Scope of Work:

Camp Sweeney

Wireless Access Points:

- a) Interior AND Exterior of the Dining Hall.
- b) Interior AND Exterior of the Recreation Building.
- c) Exterior of Dormitory Building.
- d) Exterior of the Administration Building.
- e) Exterior yard/ basketball court.

Included at interior and exterior:

- a) Conduit and wall penetrations
- b) Grounding

Alameda County Juvenile Justice Center

- a) Conduit installations. Primary conduit run installed at the upper floor mezzanine with select branch conduits
- b) Core drilling at select concrete penetrations. Includes scanning of concrete before coring.
- c) Supply 20 amp circuits at select IDF locations.

General Notes

Based on a GSA walk through of both the Camp Sweeney and JJC locations, rough quantities are as follows (contractor to verify):

- a) 40 each wall/ floor penetrations that ranged in sizes 3/4" to 4" diameter.
- b) 30 each 20 amp circuits, 2 circuits at each cabinet and rack (assume tie back to panel at 150')
- c) Conduit: 3/4" EMT conduit = 432 LF; 1" EMT conduit = 480 LF; 2" EMT conduit = 1248 LF; 3" EMT conduit = 432 LF; 4" EMT conduit = 960 LF
- d) Assumes that the existing piping racks at the JJC mezzanine will be utilized for all new conduit installations.
- e) All penetrations will be fire caulked by E-3 Systems after placing cable per their proposal.
- f) Permits County to provide
- g) Cabling by others
- h) Equipment to be provided and installed by County ITD to be confirmed by the County
