Brief Scope: 01/10/2020 Brief Scope: To enhance safety for the Treasurer Office staff, the project is to manufacture

and install custom frame with glazing and a pass-through window at each transaction booth. • Install tempered laminate glass panels (thickness TBD) from transaction countertop to 12" from bottom of overhead soffit. Glass to cover exposed areas on either side of transaction counters, leaving a pass-through area open at each booth. • Transaction windows to have round speak-through holes trimmed out to match existing metal framing • Install five pass-through trays trimmed out to match existing metal framing • The existing glass wing panels will be removed and re-used. • Replace existing transaction countertops with wider tops (width TBD). • Existing casework will remain. • Panel supports attach from ceiling or other structurally sound location. • All metal supports and framing will match existing metal framing at the windows located behind the Taxpayer Information counters. • Modifications to the HVAC system, electrical receptacles or fire alarm systems are included in the scope. Owner Furnished Tables • Install two owner furnished adjustable height tabletops at wall to the left of the Taxpayer Information windows. • Provide backing for mounting of tables. • Mount power strip below tables using power at nearby outlet • Relocate existing data to table locations. • Voice, data infrastructure or wireless access points are excluded. If required, the treasurer office can request a proposal from ITD outside of this project.
