| Brief Scope:     | Demolition; construction of walls; reconfiguration of work stations; and installation of power drops.<br>Adjusting the ceiling grid, lighting and HVAC. Patch and paint walls. |

The following items detail the scope of work as discussed at the site. All requirements necessary to accomplish the items set forth below shall be considered part of this scope of work:

1)Demolition: Salvage all items for reuse, as noted on drawings. - Walls, doors and sidelights. - Ceilings, recessed lights and exit signs. - Cabinets and countertops. 2)Construct new walls and new doors/sidelights. - Create new rooms and closets. - New sliding doors at closets. - Move door and sidelight in existing offices. - Add new sidelight in an existing office. - Modify fire-rated corridor, including new walls, exit doors and related hardware and closers. 3)Modify the fire sprinkler system, as required by new work, including design of required modifications. 4)Relocate recessed fire extinguisher. 5)Modify and rebalance the HVAC as required by new work. 6)Reconfigure the ceiling grid and ceiling tiles as required by new work. 7)Electrical: - A step-down transformer may be needed. - Install power drops to the work stations. - Relocate floor outlets above new casework. Add new outlets as shown. - Reconfigure recessed lighting as indicated. Relocate fixtures, relocate and provide new light switches. 8)New casework and countertops as shown on drawings. 9)Patch and paint walls. 10)Install new carpet tiles and patch existing as shown. 11)New finishes as noted. 12)New interior signage. - Signage at all new/ relocated doors. - Relocate exit signs at modified corridors. - Other locations as noted. 13)Provide submittals of product and finishes. 14)Attend periodic construction meetings.
