FINAL SUMMARY ACTION MINUTES ALAMEDA LOCAL AGENCY FORMATION COMMISSION REGULAR MEETING

January 14, 2010

1. Call to Order and Roll Call

Chair Foulkes called the meeting to order at 4:30 p.m.

Roll was called. A quorum was present of the following Commissioners:

2. Public Comment

Commission Chair asked if anyone from the audience wished to address the Commission on any matter not listed on the agenda and within the jurisdiction of the Commission. There were no comments from the public.

3. Approval/Correction of Minutes

Upon motion by Commissioner Santos and second by Commissioner Wieskamp, the minutes of September 10, 2009 were approved.

4. City of Hayward Out-of-Area Service Agreement – Arbutus Court (Padilla & Rose)

Staff gave a summary of the written report. Upon motion by Commissioner Haggerty and second by Commissioner Wieskamp, the Commission unanimously approved the application.

5. Mt. Eden Reorganization Phase II - Annexation to the City of Hayward and Corresponding Detachment from and Sphere of Influence (SOI) Amendments to the Alameda County Library District and the Alameda County Fire Department

Following a summary of the written report by Staff, David Rizk from the City of Hayward responded to several questions from the Commission. Upon motion by Commissioner Steele and second by Commissioner Santos, the Commission unanimously approved the reorganization.

Commissioner Steele inquired if the residents of the annexed island areas would be allowed to vote in the upcoming June elections. Staff responded that it would depend on the date that the Certificate of Completion is recorded and when the required documents were received by the Registrar of Voters. Staff stated that she would look into the various deadlines and report back to the Commission.

6. Alameda County Water District Annexation – BART Warm Springs Station

Staff provided a summary of the written report which included a recommendation to include an additional four parcels in the annexation in order to eliminate an unserved island area. Staff informed the Commission that written permission had been received by the property owners of these additional parcels to include them in the annexation. A representative from the Alameda County Water District responded to questions from the Commission.

Upon motion by Commissioner Haggerty and second by Commissioner Wieskamp, the Commission unanimously approved the annexation, including the additional four parcels as noted in the Staff Report.

7. Mid-year Financial Report FY 2009-2010

Staff summarized points on the written report.

Upon motion by Commissioner Sblendorio and second by Commissioner Steele, the Commission received and filed the report.

Staff indicated the process for holding Special District Election has been initiated. Nominations are due by March 12 and the election is set for April 14.

Staff indicated the Alameda County Board President and Clerk of the Board would be informed of Commissioner Haggerty's term expiration.

Chair Foulkes reported that according to Alameda LAFCo Policies and Procedures, the Commission had the option of nominating the incumbent Public Member to serve another term. Commissioner Sblendorio indicated his willingness to serve for a second term and the Chair requested that the item be placed on the agenda for the March 11, 2010 meeting.
