Staff provided a summary of the written report that included the recommendation that the Commission consider a condition of approval requiring Dublin San Ramon Services District (DSRSD) to provide evidence to LAFCo that the district's agreement with the property owner has a provision requiring consent to annexation should the district request it.

Staff reported that a majority protest was not received at the protest hearing held June 16, 2014 regarding dissolution of the Curbside Recycling County Service Area and its annexation to the Oro Loma Sanitary District. Upon motion by Commissioner Thorne and second by Commissioner Wieskamp, the Commission approved the Reorganization of the Curbside County Service Area and Annexation to the Oro Loma Sanitary District without an election pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000. ### 11. Fairview Fire Protection District Strategic Planning Update

Following brief remarks from Staff, Mike Preston, Consultant for the Fairview Fire Protection District (District), provided an overview of the District's efforts to comply with the conditions of the provisional Sphere of Influence (SOI) adopted by LAFCo on November 14, 2013. The District has contracted with the Consulting Team LLC to assist with strategic planning and community outreach and has met the first condition of having a time table and work plan by July 1, 2014.

## 12. **County-wide Wastewater Services Presentation**

Staff provided a brief overview and stated that the purpose of the presentation was informational only and no action was requested. The following agency representatives presented information regarding water services provided by their agency:

- Mike Connor, General Manager, East Bay Dischargers Authority

#### 13. **Tri-Valley Utilities Coordination/Integration Study Presentation**

After a brief introduction by staff, Dan McIntyre of the City of Livermore presented the Tri-Valley Utilities Coordination/Integration Study. The study included six agencies: Cities of Dublin, Livermore, Pleasanton and San Ramon; Dublin San Ramon Services District and Zone 7. These agencies, working with the consultant Management Partners, reviewed the following services: water, recycled water, waste, storm drainage and flood control. Also studied were coordination opportunities, integration opportunities and options for governance models. Agency governance and policies vary, due in part to each agency's response to the services needs of the time.

Currently all agencies are performing their functions efficiently and there are no known service deficiencies, no non-compliance issues and no financial crises.

The Tri-Valley Utility Ad Hoc Committee has taken the following actions as a result of the Phase 1 study:

- Endorsed a continuation of existing cooperative efforts
- Will finalize a "Reciprocal Services Agreement"
- Administrative consideration of near-term coordination opportunities
- Defer consideration of integration and governance options which would require a larger, more comprehensive study and negotiation

#### 14. Nominations for CALAFCO Board of Directors

There were no nominations for the 2015 CALAFCO Board of Directors.

As required by CALAFCO bylaws, Alameda County LAFCo designated Commissioner Vonheeder-Leopold the voting delegate and Commissioner Sblendorio the alternate voting delegate at the CALAFCO business meeting to be held at the 2014 Annual Conference in Ontario.
