Alameda County Director of Public Works, Daniel Woldesenbet, P.E., Ph.D., on Tuesday, July 13, 2021, presented for approval by the Board of Supervisors, plans and specifications for STORM DAMAGE REPAIRS ALONG CROW CANYON ROAD FROM MILE MARKER 6.0 TO MILE MARKER 6.25.

The project consists of repairs to damaged road shoulders, including retaining walls, steel piles and guardrail replacement to provide safe vehicular traffic and decrease the risk of sediment entering the nearby Crow Creek.

The estimated construction cost of the project is \$1,850,000. Work is expected to begin in April 2022 and be completed by November 2022

There is a pre-bid meeting for all prime contractors. Interested subcontractors are invited and encouraged to attend the pre-bid meeting. The pre-bid meeting has been scheduled for **Tuesday, February 1, 2022**, 10:00 a.m. The pre-bid meeting will be held virtually. Phone Conference ID: 873 710 094#. All prime contractors and interested subcontractors are invited and encouraged to attend. Attendance of Pre-Bid meeting is one of the requirements to fulfill Good Faith Effort for meeting DBE requirements.

Bids must be made on bid forms obtained from the Public Works Agency and must be signed by the Bidder and accompanied by a cash deposit, cashier's check, certified check, certified without qualification and drawn on a solvent bank of the State of California or a National Bank doing business in the State of California and made payable to the COUNTY OF ALAMEDA, or a bid bond, prepared on the form provided by the County, to be retained by the County as agreed. Said deposit, cashier's check, certified check, or bid bond shall be in the amount of 10% of the amount of bid. All bids will be received by the Director of Public Works until **Tuesday, February 15, 2022**, at 2:00 p.m.

The successful bidder must have a valid contractor's license, Classification A.

All attendees to the pre-bid meeting and bid submittal will be required to comply with any applicable Health Order that is in effect on the date of meeting/attendance, including any requirement to wear a face covering, if any. More information on health orders and guidance is available here:
