Alameda County Director of Public Works, Daniel Woldesenbet, P.E., Ph.D., on Tuesday, July 13, 2021, presented for approval by the Board of Supervisors, plans and specifications for STORM DAMAGE REPAIRS ALONG CROW CANYON ROAD FROM MILE MARKER 6.0 TO MILE MARKER 6.25.

The project consists of repairs to damaged road shoulders, including retaining walls, steel piles and guardrail replacement to provide safe vehicular traffic and decrease the risk of sediment entering the nearby Crow Creek.

The estimated construction cost of the project is \$1,850,000. Work is expected to begin in April 2022 and be completed by November 2022

Said deposit, cashier's check, certified check, or bid bond shall be in the amount of 10% of the amount of bid. All bids will be received by the Director of Public Works until **Tuesday**, **February 15, 2022,** at 2:00 p.m.

The successful bidder must have a valid contractor's license, Classification A.
