ABOUT

Innovations in Reentry, formerly known as the Realignment Innovations Fund, is a pilot grant program designed to support innovative approaches to addressing the needs of the adult reentry population and reducing recidivism in Alameda County.

FUNDING AMOUNTS

\$1,960,000 in funding is available through Innovations in Reentry grants for proposals from qualified applicants.

- *Collaborations between two or more entities* may request funding up to \$400,000.
- *Individual organizations* may request up to \$200,000.
- *Individuals and informal groups with a 501(c)3 fiscal sponsor* may request up to \$25,000.

WHAT IS INNOVATION?

Innovative projects must promote new approaches to reentry in one or more of the following ways:

- *Introducing* a new practice or approach with practical application in the field, or
- *Adapting* an existing practice or approach, so that it can serve a new population or setting, or
- *Modifying* an existing practice or approach from another field, to be used for the first time in the field of reentry.

GUIDING PRINCIPLES

Priority will be given to proposals that do one or more of the following:

- *Ensure culturally appropriate strategies*, including using a trauma or healing-informed approach, and are responsive to the individual needs of the populations that they are serve.
- *Support leadership development* and tap into the wisdom and experience within the reentry community.
- *Support the individual, family and community*. For example, projects that provide benefits to the broader community beyond services to the client, promote healing between clients and their family/community, or improve public perceptions of the reentry community.
- *Reflect coordination or collaboration*. Reentry service providers; community and faith-based organizations, unions, businesses, educational and cultural institutions, local departments, county agencies, and individual content experts are encouraged to partner to submit a grant proposal.
- *Encourage systems change or improve systems integration* in order to provide better services to the client and /or reduce recidivism.
- *Produce tangible organizational assets* - a program design, set of strategies, or training curriculum - that county agencies could use to change internal systems to better respond to the needs of those affected by the criminal justice system.
- *Serve populations at highest risk for recidivism*. Please visit www.InnovationsInReentry.org for data on populations supervised by the Alameda County Probation Department.
