Transportation Suggestions (needs of realigned clients)

- Survey monkey to assess needs & listening sessions.
- To services (keep enrollment going)
- Mental Health needs (special transport?)
 - o E.g. use medi-cal "non-medical transportation" at discharge planning

Sharon Aminy

- Also for non-covered transport could arrange peer-to-peer transport? (peers hired to be drivers)*
- o *keep liabilities and training in mind. May need training and insurance funds. Cost difference if program in-house or framed out. Put limits on purpose of transport and no passengers (8 or below). Think about economics of scale.
- Look at Centerforce transport program funded by CDCR
- Contract with existing transport company? (call-in center)
- Look at East Oakland Recovery Center (Bi-Bett), transport from Santa Rita to TX services, by court order or with 14 day window.
- The coordinator should be community-based instead of Sherriff Office staff (to lower cost).
- Look at transport program mentioned at Empowerment Summit at Merritt
- Model of ACAP program with post-release waiting center and transport (10 years ago) but improve on waiting room.
- Model of DSS Shuttle for UPS employees with night shifts. Look at where people commonly employed post-release.
- Student transport by Reset Foundation (post-release) and crisis transport (class C drivers)
- Talk to AC Transit and 2-1-1
- A Safe Place provides emergency domestic violence transport and taxi service (especially with open CPS cases)

GAPS AND EXISTING SERVICES

- ACAP
- On-call transport (highly costly)
- Is this worth the cost of the liability
- Those who don't have case managers are the population
- Need additional funding streams
- Non-medical transportation (Steve Weiss) to hire formerly incarcerated as drivers. What to do for those with seriously mental issues?
- Where does/would the training come from, and who is going to pay for such training?
 - o Would they all be formerly incarcerated drivers?
 - It is hard to get insurance for "live bodies", could be extremely costly.
 - The cost of night vs. day drivers

RESOLUTIONS

- The organizations and the hub of transportation, coordinate call-in call center
- A need for a coordinator to connect the venders to clients.

PARKING LOT — RELATED NEEDS

- Crisis stabilization center
- Mental Health Case Management

FAMILY REUNIFICATION STRATEGIES

- Create flexibility for some cases
- Paths to Success identified first 2-3 months when parents reunified in CPS case. Need intensive support.
- Client has a lot of legal issues in Dependency Court. Alameda County Public Defender's Office wants to bring in lawyers to improve level of representation with SW in-house (team approach)
- Mediation needs (and success through creative solutions) with substitute caregivers, e.g. probate court guardianships. Shared decision making and shared expectations, etc. (pre- and post-release)
- Family reunification program in Contra Costa County based on same idea of mediation. Look at AB109 new model similar. (pre- and post-release)
- Housing needs at reunification
 - Look at domestic violence eligible housing; domestic violence can be an issue for reunification.
 - Shelter and transitional housing issues. Some programs charge clients.
- ACCIPP distributing survey to assess what family reunification services are being provided, any evidencebased practices, etc. (resent by Neola Crosby)
- ACCIPP provides technical assistance to providers and can provide to grantees.
- Interdisciplinary family defense in CPS and dependency cases improves outcomes for children, equip parents to successfully reunify, and address family needs to stabilizer.
- Need for crisis hotline for parents and support groups.
 - Strengthen PCAG support group? (open for new members)
- Home-based programs can be very preventative and effective, especially mental health needs. (greater accessibility); home-based services help to develop a trusting relationship.
- Housing barriers to reunification (e.g. criminal record look to expungement with Alameda County Probation Department and East Bay CLC)
- Get in touch with HUD
 - About whether to work with rules. Lily Zimmerman helped work with OHA on federal level.
 - Legal BALA assistance is key to challenge denied of housing from public housing/HUD.
- Reduce barriers for parents (with felonies) who want to work with their children.

- SUGGESTIONS/CONSIDERATIONS

 Use volunteers to assist with family reunification

 - Check HUD to determine housing barriers
 Barrier removal services Bay Area Legal Aid
 Impacted individuals telling their story could be traumatizing
