SUBJECT: PROCUREMENT UPDATE

Attached is an updated progress report on County Procurement. The data presented in the report is for the period July 1, 2008 through June 30, 2011 with comparisons to July 1, 2005 through June 30, 2008. As you can see on Page A from the summary chart of all contracts up to \$500,000 dollars for the period July 1, 2008 through June 30, 2011:

- 69.77% of all contract dollars were awarded to local vendors
- 44.76% of all contract dollars were awarded to MBE/SLEB vendors
- 43.23% of all contracts awarded went to MBE/SLEB vendors
- More than 42% of all contract dollars in each purchasing category were awarded to MBE/SLEB vendors
- More than 42% of all contracts in each purchasing category were awarded to MBE/SLEB vendors

When the data is compared for July 1, 2005 through June 30, 2008 on the summary chart on Page B we find that:

- 70.30% of all contract dollars were awarded to local vendors which is consistent with the current period
- 34.71% of all contract dollars were awarded to MBE/SLEB vendors which is 10% less than the current period
- 26.20% of all contracts awarded went to MBE/SLEB vendors which is 17% less than the current period
- The percentage of all contract dollars in each purchasing category awarded to MBE/SLEB vendors is higher in the current period with the exception of the construction category decrease of 2.61%

Side by side comparisons for Fiscal Years by Purchasing Category are provided on pages 1-5.

Currently the County has certified approximately 1,300 SLEB vendors and approximately 5,000 MBE vendors in our vendor database. We are continually working to increase the number of SLEB/MBE vendors. The most recent event we attended to encourage local vendors to do business with Alameda County was the Solano Stroll on September 11, 2011.

We are also in the process of updating the County's SLEB/MBE and local vendor database. Currently we have over 8,000 local vendors in the database. This database provides the County departments with a selection of local vendors to procure goods and services. In order to expand the database we have sent letters to local chambers of commerce offering assistance for their members to become SLEB certified. We will be doing a presentation for the Hayward Chamber on doing business with Alameda County.
