Attached is an updated progress report on County Procurement. The information presented in this report is based on payments made to contractors. The summary chart of all payments up to \$500,000 for the period July 1, 2009 through March 31, 2022 is shown on Page A1 and includes:

- Total payments up to \$500,000 were \$1.7B
- \$1.0B was paid to local contractors which equals 61.21% of total dollars up to \$500,000
- \$838.5M was paid to MWBE/SLEB contractors which equals 49.31% of total dollars up to \$500,000
- Payments to MWBE/SLEB contractors by category were:

Construction:	\$83.1M which equals 38.54% of Construction dollars
Architecture & Engineering:	\$22.9M which equals 51.06% of Architecture & Engineering dollars
Professional Services:	\$323.3M which equals 60.68% of Professional Services dollars
Goods & Services:	\$409.2M which equals 45.10% of Goods & Services dollars

Also included in this report are all payments to contractors including amounts over \$500,000. This data is presented in the summary on Page A2 for the period July 1, 2009 through March 31, 2022 and includes:

- Total payments were \$3.8B
- \$2.1B was paid to local contractors which equals 55.24% of total dollars
- \$1.4B was paid to MWBE/SLEB contractors which equals 35.85% of total dollars
- Payments to MWBE/SLEB contractors by category were:

Construction:	\$220.4M which is 30.27% of Construction dollars
Architecture & Engineering:	\$27.8M which is 35.50% of Architecture & Engineering dollars
Professional Services:	\$432.3M which is 30.58% of Professional Services dollars
Goods & Services:	\$680.7M which is 43.16% of Goods & Services dollars

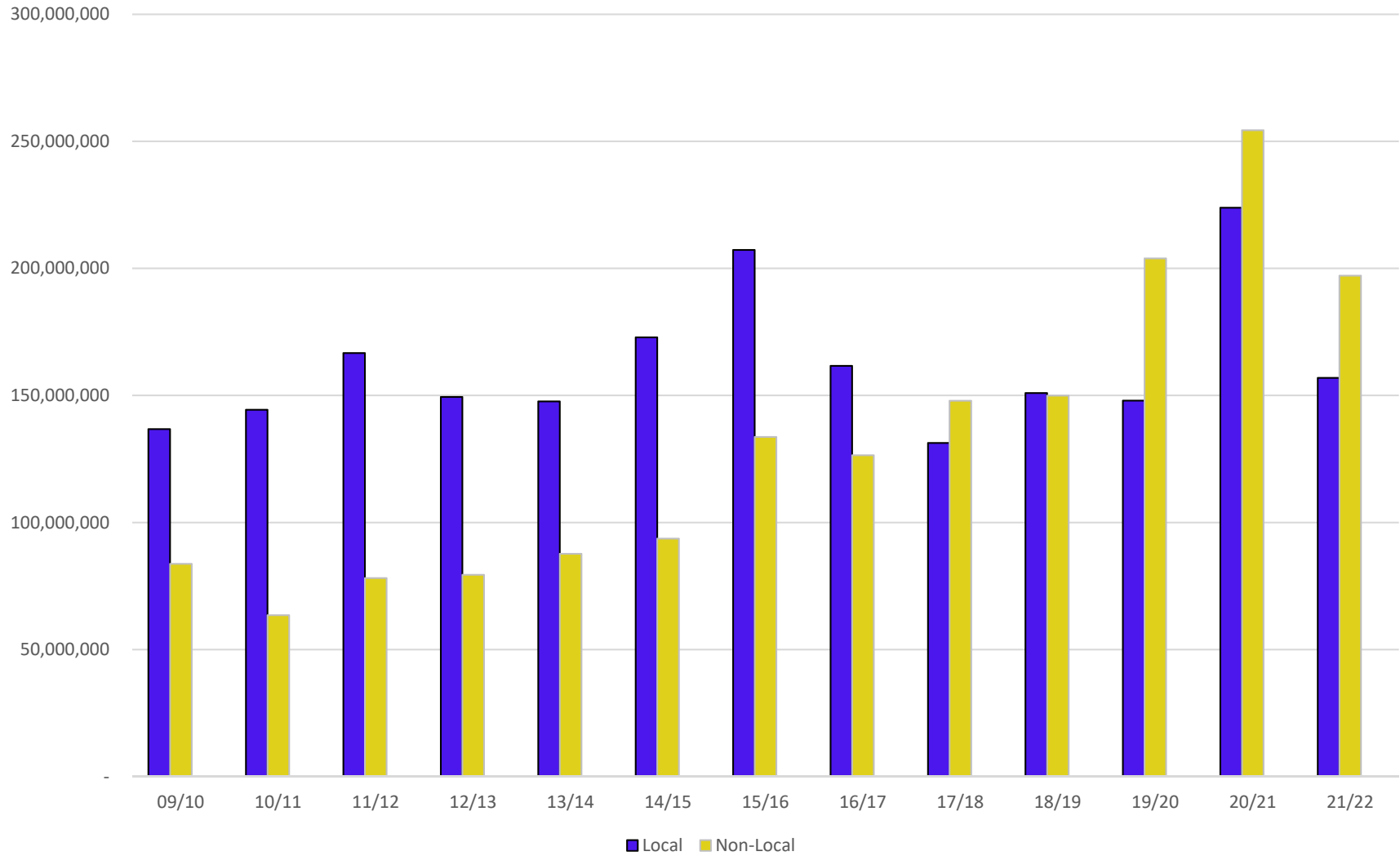
### Overall Local Utilization by %

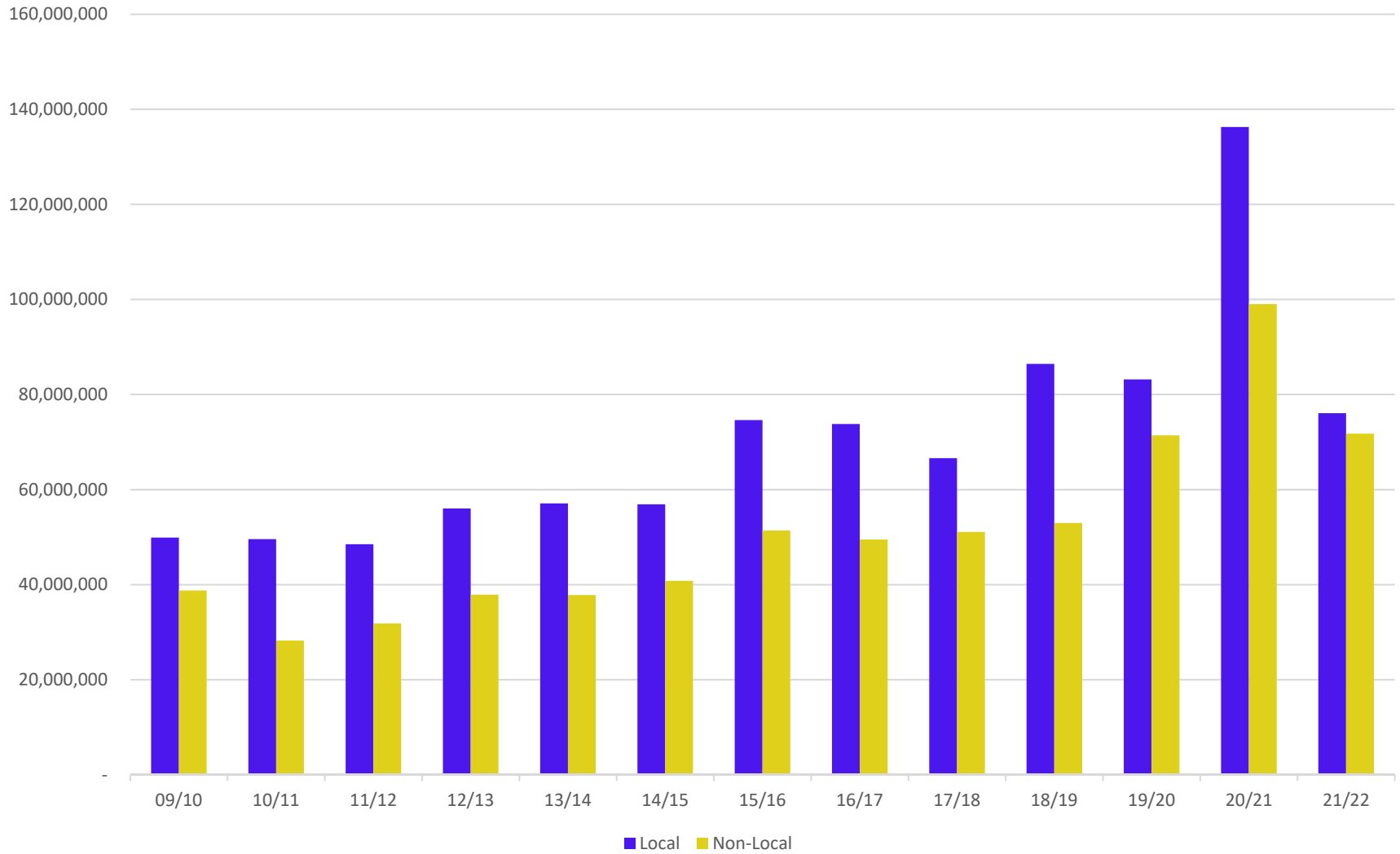

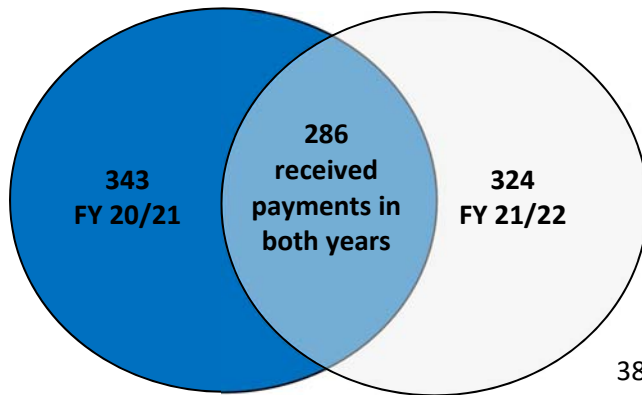
# SLEB Breakdown by Ethnicity and Gender March 31, 2022



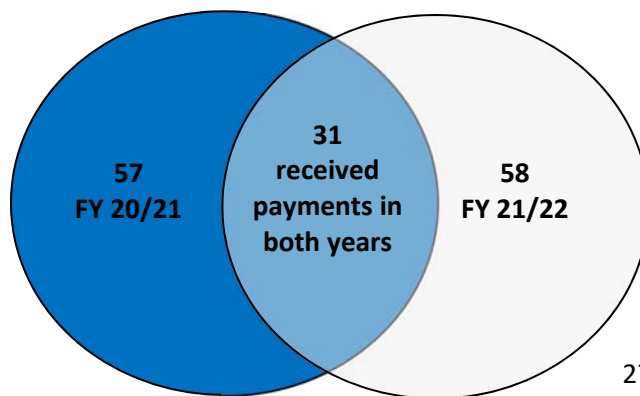

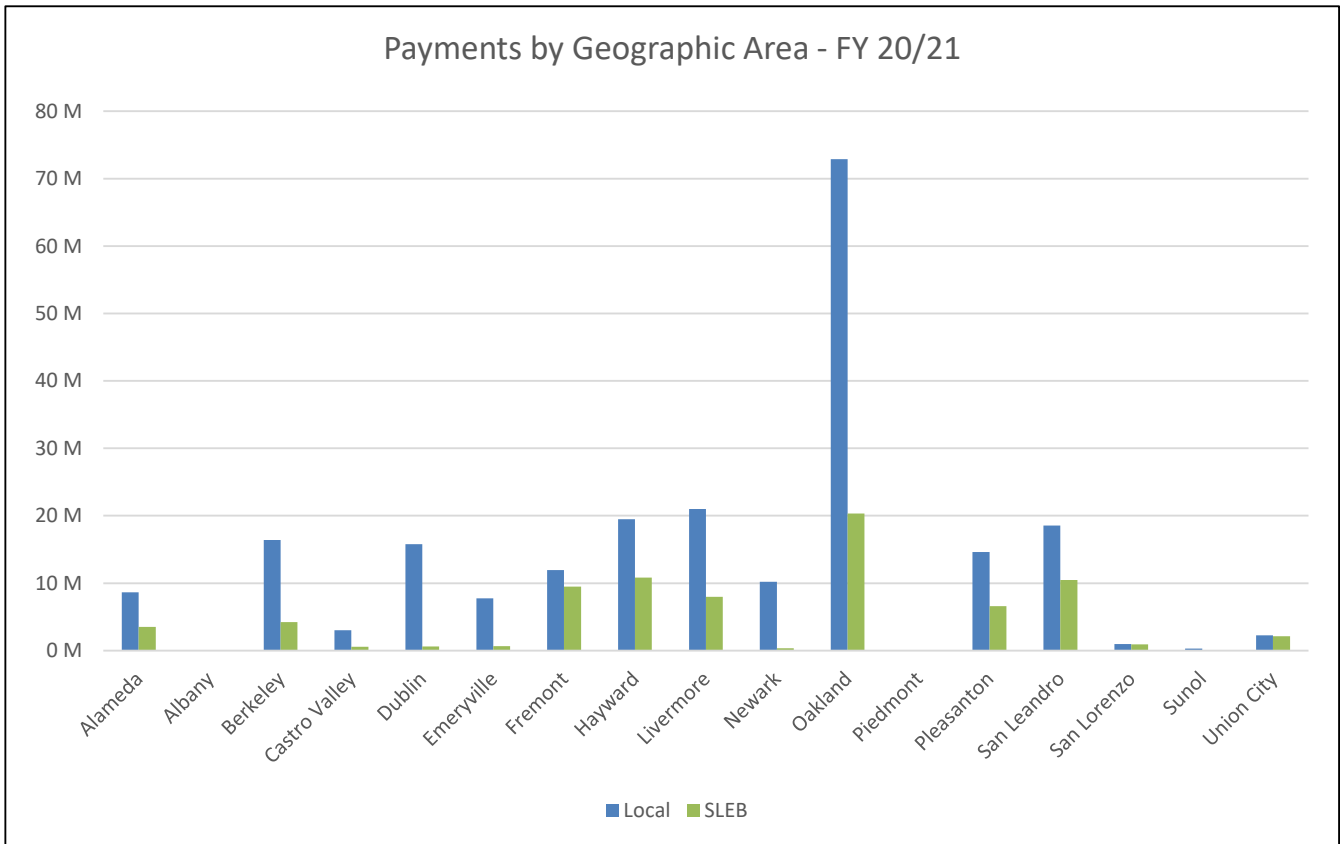
