

## Background: SB 1383

- Short-Lived Climate Pollutants Act, passed in 2016
- Aims to reduce methane and other climate pollutants by mandating:
  - Organic waste be diverted from landfills, and
  - Surplus edible food be recovered for human consumption
- CalRecycle given authority to promulgate regulations to meet these objectives
- Regulations took effect January 1, 2022

## **How Paper Fits In**

- Generators (residents & businesses) are required to recycle paper
- With more paper being recycled, there is a need to support development of end markets
- Regulations require jurisdictions to purchase post-consumer recycled content paper to help build these end-markets for recycled paper

#### Other Benefits

- Reduce deforestation
- Lower GHG emission of producing paper
- Meet city policy goals for environmental purchasing or climate action



## **Key Terms**

- Jurisdictions: Cities, counties or sanitary districts providing solid waste collection services
  - These are the only entities the regulations apply to
- Post-consumer<sup>1</sup>: Consisting of or incorporating material discarded by end users rather than generated during a manufacturing process
  - This distinction is important to supporting development of end-markets for paper recycled at the curbside by generators





## Paper Purchasing\* Requirements for Cities

- 1. Purchase paper products with a minimum of 30% post-consumer recycled content
- 2. Ensure that the paper purchased is recyclable
- 3. Maintain records certifying compliance

\*Definition from SB 1383 regulations: "Paper Purchase" means all purchases by a jurisdiction of items in the following categories: (A) Paper products. (B) Printing and writing papers.



Purchase papers with a minimum of 30% post-consumer recycled content (PCR)

- Reinforces existing public contract code<sup>1</sup>
- Allows for exceptions for fitness, quality, or higher cost
  - Cities must maintain justifications for non-compliant purchases in implementation record
- Applies to all paper purchases, including printed material distributed by cities

#### Vendor Tips

- Identify products with 30% PCR products in your catalogs, invoices, or other documents
- Seek new suppliers who can provide cost-competitive compliant products





Recyclability

Purchase papers that are eligible to be labeled with an "unqualified recyclable label<sup>1</sup>"

- Means recycling facilities are available to 60% of consumers
- Law requires <u>vendors</u> to certification of recyclability in writing
- Per CalRecycle, will not be enforced for products that cannot be recycled, like janitorial papers

#### Why Recyclability?

 Purpose is to avoid purchasing products that end up being landfilled anyway, such as multi-material products





Recordkeeping

### Maintain all documents supporting compliance

- Proof of purchase of all paper products by volume and type
- Certifications and verification for:
  - Post-consumer recycled content
  - Recyclability
- All other documentation supporting compliance
  - Such as the reason for purchase of non-compliant products

#### Vendor Tips

- Include information on PCR amounts and recyclability on invoices, usage reports, or product certification form.
- Provide records within 60 days
- Provide documentation to help jurisdictions justify noncompliant purchases, when quality or cost is not equal





### For all paper products purchased, show:

#### **Recycled Content**

- Vendor can certify in writing, e.g., usage report or product certification form
- Or maintain verification from a product label, catalog, invoice, manufacturer or vendor website, etc.

Provide documentation that helps cities to justify purchases that are not compliant

#### **Recyclability**

 Vendor must certify in writing that products are eligible to be labeled with unqualified recyclable label



## **Reporting Format Examples**

#### **Recycled-Content and Recyclable Paper Certification**

CalRecycle is providing this form as a convenience to assist jurisdictions. Beginning January 1, 2022, jurisdictions are required to purchase and obtain documentation certifying that paper products and printing and writing papers:

- 1. Contain postconsumer recycled content (PCRC)<sup>1</sup>
- 2. Are eligible to be labeled with an unqualified recyclable label<sup>2</sup>

All businesses shall certify in writing under penalty of perjury to the jurisdiction's contracting officer or representative:

- The minimum percentage, if not the exact percentage, of PCRC material in the paper products and printing and writing papers offered or sold to the jurisdiction, regardless of whether the product meets the minimum content requirements specified in law.
  - a. A jurisdiction may waive the PCRC certification requirement if the percentage of postconsumer material in the paper products or printing and writing papers can be verified by a product label, catalog, invoice, or a manufacturer or vendor Internet website.
- 2. That the paper products and printing and writing papers offered or sold to the jurisdiction are eligible to be labeled with an unqualified recyclable label as defined in 16 CFR Section 260.12.

#### Example Usage Report Format From Alameda County

Key categories shall be defined as:

- a) Purchase date
- b) Purchase Order Number
- c) Department Name
- d) Manufacturer item number
- e) Item description (e.g. brand, size, color, etc.)
- f) Unit of measure (e.g., ream, carton);
- g) Number of individual pieces per unit;
- h) Units purchased (i.e., order quantity);
- i) Shipped quantity (if not same as order quantity);
- i) Unit price (i.e., charge to customer); and
- k) Total order cost.
- ) Percentage of post-consumer content
- m) Recyclable? (y/n)

### SB 1383 Paper Procurement Factsheet

Adapted from CalRecycle Website (www.calrecycle.ca.gov/organics/slcp)

As of January 1, 2022, SB 1383 requires jurisdictions (defined as: cities, counties, or special districts that provide solid waste collection services) to purchase paper products that are recyclable and contain at least 30% post-consumer recycled content when they are available in the marketplace at competitive costs and are equal in performance.

All paper products and printing and writing paper are covered. Below are examples of paper products commonly purchased by local governments.

#### Recordkeeping

Cities will need to maintain records showing the post-consumer recycled content and recyclability of all paper purchases, including:

- Copies of invoices, receipts, vendor reports, or other proof of purchase that detail the procurement of paper products by volume and type.
- Written certification(s) of the recycled content of each paper product. These can come from:
  - Paper vendors, such as a usage report
- Manufacturer or vendor websites
- Product labels, invoice, receipts, etc.
- Written documentation from the product vendor certifying the products are recyclable.

Alameda County has compiled this information to support local government compliance efforts with SB 1383. The County makes no warranties and accepts no responsibility for compliance of other jurisdictions. Seek the advice of your legal counsel for questions. Last updated March 1, 2022, for a vendor audience. When paper, food waste and other organic materials are buried in a landfill, they produce methane, a potent climate warming pollutant. The procurement requirements in this law set out to create demand for these materials to ensure they will have a useful second life, and not end up in the landfill.

Why Focus on Paper?

As a vendor, your partnership is critical to the ability for cities to comply with this law. We encourage you to become familiar with the law so you can proactively help cities comply.



### **Questions Cities May Ask** When Soliciting Bids from Paper Vendors


- Do you have a reporting template to provide product tracking information required by SB 1383? Can you provide this report upon request within 10 days?
- Are you **already providing** SB 1383 compliant tracking information for other buyers?
- Do you have an indication in your catalog for SB 1383 compliant products? What about noncompliant products?
- Can you provide a separate list of SB 1383 compliant and non-compliant products you have available?
- Please describe how buyers find SB 1383 compliant products while purchasing?
- If compliant products are not available or are more costly, are you able to document this to help with record keeping requirements?
- If you don't currently carry compliant products, but they are available in the marketplace, are you willing to source from new suppliers?
- Can you compare non-compliant and compliant products by price (e.g., conduct a market assessment)?
- Can you provide certification in writing that paper products sold are recyclable in local recycling programs?
