Level 3 Diesel Particulate Filters Bid

Background

The State of California classifies particulate matter as a toxic air contaminate that reduces air quality and contributes to public health issues including asthma, heart disease, and cancer. In 2008, the <u>California</u> <u>Air Resources Board (CARB)</u> announced requirements that level 3 Diesel Particulate Filters (DPFs) must be installed on all heavy duty diesel trucks in the State, including public fleets. The Alameda County Public Works Agency (PWA) managed the process of installing DPFs on the County's fleet of heavy duty diesel trucks. With the installation of the Level 3 DPFs, the County complied with the CARB requirements and reduced the amount of particulate matter expelled from these diesel engines by more than 85 percent.

STATEMENT OF WORK

A. <u>INTENT</u>

Alameda County Public Works Agency (PWA) intends to retrofit their fleet of heavy duty diesel trucks to meet upcoming regulations issued by the California Air Resources Board (CARB). It is the intent of this Request for Quotation (RFQ) to describe the goods and services that are required by PWA to select the lowest responsible bidder who has the necessary qualifications and competency to supply and install Level 3 Diesel Particulate Filters (DPF) on PWA's fleet of heavy duty diesel trucks.

The County intends to award a three (3) year contract (with option(s) to renew) to the bidder selected as the lowest responsive and responsible bidder meeting the County's requirements as stated in this RFQ.

B. <u>SCOPE</u>

This project described herein will be for the purchase and installation of DPFs on 30 vehicles, all of which are itemized in the Specific Requirements section of this RFQ. DPF installation on the specified vehicles is to be completed by December 31, 2009.

PWA utilizes a bio-diesel blend of 20% bio-diesel and 80% diesel (B20) to fuel its diesel fleet. The selected bidder shall provide and install level 3 DPFs on the specified fleet of B20 fueled vehicles. Any DPF installed is to have been certified by CARB to meet level 3 standards using a bio-diesel blend of 20%.

The vendor awarded this contract will be responsible for providing and installing the DPFs at various locations throughout Alameda County. The vendor is expected to provide all data logging necessary in order to verify that the exhaust temperature range on each vehicle meets that which is required (according to manufacturer's specifications on each DPF provided by vendor) to support the DPF installed by the vendor.

C. <u>SPECIFIC REQUIREMENTS</u>

The intent of these specific requirements is to define the DPFs and installation to be performed on the 30 heavy duty diesel trucks selected to undergo this modification.

- 1. The serial number for each DPF shall be included on the invoice along with the corresponding vehicle identification number (VIN) on which it was installed.
- 2. Vendor must provide documentation which includes proof of CARB certification for each DPF installed.
- 3. The selected bidder will be required to perform any data logging required to verify the exhaust temperature range needed to support the type of level 3 DPF required.
- 4. The diesel particulate filter required must be certified by CARB to meet level 3 standards using a bio-diesel blend of 20%, and the installation must comply with all CARB regulations.
